



## 'Annaatthe' collection good

Chennai, Nov 6: Siruthai Siva's directorial 'Annaatthe' starring Rajinikanth had been released on Diwali (Nov 5), and the film was loaded with audience cheer right on the FDFS. The grand festival is celebrated by cinema fans with 'Annaatthe' this year, and Superstar Rajinikanth has given an above-par performance. The latest reports suggest that

Rajinikanth's film has surpassed the box office collection of Vijay's 'Sarkar' and is set to become an all-time day 1 record in Tamil Nadu. The Tamil Nadu government granting 100% occupancy in theatres recently has turned as a boon for 'Annaatthe', and the film has reportedly grossed more than Rs 34 crore at the Tamil Nadu box office. By this achievement, 'Annaatthe'

has surpassed Vijay's 'Sarkar' (Rs 32 crore) to become the highest-grossing film at the TN box office on day 1. 'Annaatthe' makers have confirmed the report by liking it from their Twitter page. But there are also reports that claim that 'Annaatthe' has grossed only Rs 25 crore, and the film didn't break 'Sarkar' record.

## 'Indian 2' shoot to resume in Dec



Chennai, Nov 6: There has been a lot of buzz lately, around the long delayed 'Indian 2' directed by Shankar. While the film's shooting was stopped after an unexpected accident that occurred on the sets of the film in February last year, then COVID-19 and then the issue between director Shankar and Lyca Productions, the

latest buzz is that the shooting of the film is all set to resume soon. After almost a year now, a compromise has been arrived at between director Shankar Lyca Productions, which is bankrolling the project and the court has closed the case. Reports are that 'Indian 2' will surely resume from the mid of December and will go on for at least

a hundred days. Kamal Haasan too is apparently keen on completing the project, and he is expected to be free from December 15th onwards. Kajal Aggarwal and Rakul Preet Singh are playing the female leads in the film, with Priya Bhavani Shankar in an important role.

## Prehistoric dragonfly has two feet long wings



More than 300 million years ago, the Meganeura established itself as the largest known flying insect to ever exist on Earth. The dragonfly-like creature had a wingspan that stretched around 2.5 feet. The bugs were also big enough to hunt prey like frogs and newts, which it could eat with its tooth-like mandibles.

Meganeura is a genus of extinct insects from the Carboniferous period (approximately 300 million years ago), which resembled and are related to the present-day dragonflies. Its wingspan from 65 cm (25.6 in) to more than 70 cm (28 in), M. Monyi is one of the largest known species of flying insects.

## Tejas Rajdhani Express on electric traction

Guwahati, Nov 6: Indian Railway received the Commission of Railway Safety (CRS) authorization has been received for introduction of AC electric traction to and from Guwahati railway station.

According to the Ministry of Railways, Guwahati is the biggest and busiest railway station of the Northeast. It is now connected with all major

cities through 25KV AC traction.

Northeast Frontier Railway (NFR) has successfully completed Electrification work of total 649 RKM / 1294 TKM from Katihar to Guwahati. This way Total HDN (High Density Network) routes (649 RKM) falling in NFR have been commissioned with Electric Traction. This great feat will now



connect New Delhi to Guwahati on seamless Electric Traction. This is yet another effort by NFR for capital connectivity by Green

Transportation. It may be mentioned here that, Northeast Frontier Railway has already started running trains with electric traction

from the Kamakhya station with the arrival and departure of the Brahmaputra Mail with AC traction since 22nd October last.

been constructed is in the vicinity of the Sewri mudflats which is regularly frequented by two species of flamingo namely lesser flamingo and greater flamingo. Both the species of flamingo frequent the wetlands of Mumbai city during the period between November and May.

## Air India decreases domestic flights by 9%

Chennai, Nov 6: Air India has decreased its domestic flights for winter 2021. Air India will operate 9% fewer weekly domestic flights in the upcoming winter schedule than that of 2019, according to the Directorate General of Civil Aviation (DGCA). Indian airlines will operate with 4.38% fewer flights than the pre-pandemic level, the Centre announced on Thursday.

The DGCA approved 22,287 flights. "It may be noted that 22,287 departures per week have been finalised to and from 108 airports," the DGCA said in a statement. IndiGo has the highest number of flights approved under the schedule (10,243), followed by SpiceJet (2,995), Go First (2,290), Vistara (1,675), and Air Asia (1,393). Air India will operate



2,053 weekly domestic flights. SpiceJet has decreased its domestic services by 31% to 2,995 weekly flights as compared to

4,316 weekly flights that it got approved for the winter schedule of 2019. Meanwhile, the regulator added that Vistara has increased its domestic

services by 22% to 1,675 weekly flights compared to 1,376 weekly flights it had in the 2019 winter schedule.
