The museum highlights the brief history of mobsters from Bugsy Siegel to Al Capone. The downtown court hall also exhibits the judgement in handwriting by the Federal judges. The benches are there where the real gangsters sat for federal hearings in 1950-51, and where they were brought to justice.

The collection in the museum illustrates the history of organized crime through memorabilia from both law enforcement and crime bosses. Even the part of a wall from the famous St. Valentine'sDay Massacre has been installed in the venue.

The museum is divided into three floors. The most important artifacts are on the third floor (the Valentine's Day Massacre and the history of Prohibition). The second floor has weapons and a brief history of the Mob's great hits. An interesting video film takes you back to the hearing, right inside the courthouse. There are also other videos of actual events of mobsters, how they tricked the customers, killing devises of the trade and a series of big pictures of hired killers and flash back of how they commenced their life of crime and killing. There are also exhibits on the role of FBI, how they caught them and shut them down.

Other impressive displays include personal possessions and other artefacts that attract the visitors. The museum has drawn enough and more attention to the academics and tourists who have an interest in knowing "wise guy" history. The museum is just a revelation to see how power, politics, and
