

# Cops struck down Nichols with fists, batons and boots as he screamed

Video shows officers pummeling & leaving him on footpath propped against squad car

## MEMPHIS

**AUTHORITIES** released video footage on Friday showing Tyre Nichols being beaten by five Memphis police officers who held the Black motorist down and repeatedly struck him with their fists, boots and batons as he screamed for his mother.

The video is filled with violent moments showing the officers, who are also Black, chasing and pummeling Nichols and leaving him on the pavement propped against a squad car as they fist-bump and celebrate their actions.

Protesters gathered for mostly peaceful demonstrations in multiple cities, including Memphis, where several demonstrators blocked the Interstate 55 bridge that carries traffic over

the Mississippi River toward Arkansas.

In Washington, protestors gathered in Lafayette Park, across the street from the White House and

near the Black Lives Matter Plaza.

The lengthy video footage from police body cameras shows a group of officers detaining Nichols, attempting to take him down with the use of a Taser, then giving chase as he evades them. After the first officer roughly pulls Nichols out of a car, Nichols can be heard saying, "I didn't do anything," as a group of officers begins to wrestle him to the ground.

Two officers hold Nichols to the ground as he moves about, and then the third appears to kick him in the head. Nichols slumps more fully onto the pavement with all three officers surrounding him. The same officer kicks him again.

The fourth officer then walks

over, draws a baton and holds it up at shoulder level as two officers hold Nichols upright, as if he were sitting.

The video raised questions about the role and possible culpability of the other officers at the scene, in addition to the five who were charged.

The footage shows a number of other officers standing around after the beating.

Memphis Police Director Cere-lynn "CJ" Davis has said other officers are under investigation for their part in the arrest.

During the traffic stop, the video shows the officers were “already ramped,” she said. The officers were “aggressive, loud, using profane language and probably scared Mr. Nichols from the very beginning.” *AP*

## Second time in 3 years, UK airline Flybe collapses

## LONDON

**STRUGGLING** United Kingdom regional airline Flybe collapsed for the second time in three years on Saturday, putting jobs on the line and leaving passengers stranded. The airline initially slumped into bankruptcy in March 2020, shedding 2,400 jobs, as coronavirus restrictions decimated the travel industry.

However, it relaunched in April last year, flying many of the same routes out of Belfast, Birmingham and London Heathrow. In a statement, the grounded flyer said it had called in bankruptcy accountants again, and warned passengers not to travel to airports as all flights were now cancelled, including its international routes from Switzerland and the Netherlands.

The UK's Civil Aviation Authority said passengers should "make their own alternative travel arrangements via other airlines, rail or coach operators," leaving customers with lengthy and potentially expensive trips to get home.

CAA consumer director Paul Smith said, "It is always sad to see an airline enter administration and we know that Flybe's decision to stop trading will be distressing for all of its employees and customers."

The UK government said that its immediate priority would be to support anyone trying to get home and those who have lost their jobs.

“This remains a challenging environment for airlines, both old and new, as they recover from the pandemic, and we understand the impact this will have on Flybe’s passengers and staff,” it said. *AP*
