
TERMS AND CONDITIONS OF SALE:

1) For participating in E-auction, intending bidders have to deposit a refundable EMD of 10% (EMD mentioned in Description) of Reserve price by way of RTGS/NEFT/ fund transfer to the credit of account number 4343500200004101, Karnataka Bank Ltd, Central Avenue Branch, Kolkata, IFSC code KARB0000434 or by DD/ pay order favoring "Karnataka Bank Ltd., A/c - M/s Chandrima Fashions Fabrics Pvt Limited ", payable at Kolkata.
