Terms and Conditions of the Tender/Bid

- The Tender/ Bid form shall be submitted duly completed in all respect in a sealed cover/envelope, subscribed as "Offer for purchase of the immovable property" addressed to "The Authorised Officer" and the envelope should be made available to the aforesaid Branch office address, on or before the date stipulated in the public notice for sale of immovable property.
- 2. The Tender/offer form shall be accompanied by Pay Order/Demand Draft drawn on a scheduled Bank in favour of "Tata Capital Housing Finance Ltd." towards Earnest Money Deposit (EMD).
- 3. Tenders not accompanied by EMD and the tenders below the Reserve Price shall be rejected outright. The Authorised Officer has the full right to accept or reject any tender/bid without assigning any reason.
