Sub: Notice for Sale of the Mortgaged Property

- 1. We refer to Demand Notice dated 17.06.2019 issued by PNB Housing Finance Limited (hereinafter referred to as "PNBHFL") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. NHL/NAG/1117/448935 wherein PNBHFL had called upon you to pay the dues of Rs. 10,94,79,224.01/- (Rupees Ten Crore Ninety Four Lakh Seventy Nine Thousand Two Hundred Twenty Four And One Paisa Only) due and payable as on 17.06.2019 along with applicable future interest and charges applicable from 18.06.2019 until payment in full (hereinafter referred as the "Outstanding Amount") and payable by you all under the facilities granted by PNBHFL within 60 days from the date of the said Notice. You have since then failed and neglected to pay the amount as demanded.
- 2. PNB Housing Finance Limited has vide an assignment agreement dated 04-03-2023 ("Assignment Agreement") has assigned the debts due and payable by you in favour of Kotak Mahindra Bank Limited (hereinafter called KMBL/ The Bank) along with all its rights, title, interests, benefits in the facilities granted by PNBHFL with other incidental right thereto including the assignment of the said facilities along with the underlying securities. As per the said assignment agreement, KMBL has become full and absolute owner and as such is legally entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and

to take such other action as may be required for the purpose of the recovery of the said financial facility. Kotak Mahindra Bank Ltd. has been subrogated in place of PNBHFL and all right, title and interest of PNBHFL in respect of Outstanding Amount is now vested with Kotak Mahindra Bank Ltd.

- 3. It is pertinent to note that despite the service of the above mentioned notice, you have failed to liquidate the outstanding dues and as such, the Authorized officer of PNBHFL took possession of the property described herein below in Annexure "A" (and referred hereinafter as "Secured Asset") on 06.05.2022 in exercise of the powers conferred on him under Section 13 (4) of the said Act read with Rules 8 & 9 and in pursuance of order dated 25.03.2022, passed by Learned District Magistrate, Nagpur, under Section 14 of the said SARFAESI Act. Subsequent to the Assignment of the loan account, the actual possession of the mortgaged property has been handed over to KMBL by PNBHFL on 23.05.2023.
- 4. After taking possession of the secured asset, inspection was carried out by approved valuer in compliance of Rule 8(5) of the Security Interest (Enforcement) Rules, 2002 and on the basis of report of valuer, auction of the Secured Asset as mentioned in Annexure "A" was conducted on various occasions. 


