Fresh blow to Imran Khan's party as winner list notified

Pakistan's election commission on Friday notified the victories of three candidates from Nawaz Sharif's PML-N in the federal capital, delivering a fresh blow to jailed former prime minister Imran Khan's party, which had challenged the original poll results.

NA-48, putting on hold the success of three candidates of former prime minister Nawaz Sharif's Pakistan Muslim League-Nawaz (PML-N) party, who had won respectively on the three seats.

While Anjum Aqeel Khan and Chaudhry won on the PML-N tickets, Raja Khur-

ram Nawaz won as an independent candidate and joined the party after his victory.

After hearing the parties on Friday, the electoral watchdog restored the order suspended by the IHC and issued the notification announcing the victory of the three candidates.

Ex-Pak PM, wife move court against 'un-Islamic marriage' case verdict

Jailed former Pakistan prime minister Imran Khan and his wife Bushra Bibi on Friday separately moved a lower court challenging the verdict in the "un-Islamic" marriage case in which they were jailed for seven years and their marriage in 2018 declared illegal.

Earlier this month, a trial court sentenced Khan, 71, and his wife Bushra Bibi, 49, to seven years in jail and imposed a Rs 5,00,000 fine on each for "contracting marriage during the 'iddat' (period of waiting)" in a case filed by Bibi's former husband Khawar Maneka in November last year.

An Australian police officer is facing two murder charges after allegedly killing his former boyfriend and his new partner and disposing of their bodies, which are yet to be found. New South Wales police officer Beaumont Lamarre-Condon, 28, appeared in court on Friday afternoon charged with the murders of Jesse Baird, 26, and Luke Davies, 29.

eastern Sydney suburb of Paddington on Monday, and fears for their safety rose after their bloodied belongings were found in a skip in Cronulla, around 30 kilometres away.

NSW Police Detective Superintendent Daniel Doherty told reporters at a news briefing Friday that blood was also found in a search of Baird's home, as well as a "projectile" and a fired cartridge case.

firearm belongs to the 28-year-old man who was charged today," Doherty said. Police said in a statement that the off-duty officer charged was a senior constable attached to a specialist command.

An NSW Court spokesperson confirmed Lamarre-Condon had appeared in Waverley court Friday charged with two counts of murder. He didn't apply for bail.

No intermediate classes in colleges in Bihar from Apr 1

PTI/PATNA: The Bihar government announced it was going to discontinue intermediate (10+2) classes being held in colleges affiliated with various universities in the state. In a notification issued late on Wednesday evening, the Education department said that while such classes had been discontinued in Patna University about

a decade ago, the same will cease to be held at colleges falling under other varieties from the academic session beginning in April this year. According to the notification, intermediate education (in all three streams — arts, science and commerce) will now be imparted only in higher secondary schools from the new session.
