Fort Kochi gets open-air theatre, other spaces await facelift

The Rs 1.06-cr project on 385 sqm of vacant land attempts to foster vibrant cultural hub

THE gateway to Kerala's tourism destinations, Kochi has always needed open grounds and green spaces for the conduct of various activities. Aiming to provide a stage for local artists, the Cochin Smart Mission recently opened an open-air theatre in Fort Kochi.

Replete with dedicated facilities, the Rs 1.06-crore project on

385 sq m of vacant land within the Kochi Municipal Corporation Zonal office premises attempts to foster a vibrant cultural hub.

According to the Cochin Smart Mission, the theatre boasts a seating capacity of 228 persons and offers scenic views of the backwaters and fishing nets. "The landscape design with art installations and sculptures enhances the aesthetics,

while LED lighting ensures safety and security. Additionally, mural paintings add a touch of vibrancy to the space. A dedicated toilet complex with

a green room, covering 45 sq m, caters to the needs of performers and visitors," the Cochin Smart Mission highlighted in a post on its Facebook page.

The space in the corporation compound had remained vacant, with overgrown weeds and grass, for quite some time. Before getting the facelift, the

area was used to sort waste collected by the corporation workers.

But the theatre is yet to host a programme since its opening, M P Sivadathan of the Kerala Homestays and Tourism Society. "It looks pretty now. But as seen in the case of other grounds and spaces, the theatre might soon fall victim to lack of maintenance," he said.

As per tourism stakeholders, other open spaces in Fort Kochi too are in serious need of renovation and maintenance. Various studies have shown that the current allocation for open green spaces and parks in Kochi is far lower than what is required. At present, open green space comes to just 0.65 sq km, which is less than 1% of the corporation area.

THOUGH studies show women in Kerala are empowered, in reality, they are neither on nor behind the screen, said professor and director Asha Achy Joseph on Sunday.

"Kerala is considered an example of development paradox in the capitalist system. Women tend to choose professions tailored to them. They remain absent in many areas, not just cinema," said Asha during the open forum organised during the 5th Women's International Film Festival (WIFF) in Kochi.

She said though Kerala was far ahead than other states in the human development index, women were still lagging. "It is sad that most of the women who support patriarchy in India are from Kerala," she said.

Actor Jolly Chirayath, film critic Indu Rama, and documentary directors Lourdes M Supriya and Gurleen Grewal attended the event.

An officer said what was more worrying that some of the drivers caught for the offence were hardly in full control of their senses. "A few of them were not even bothered about the safety of others. It was sheer luck that none was hurt," said a police officer who was part of the inspection team. Shockingly, a large number of offenders were drivers of buses, autorickshaws, and taxis.

Meanwhile, 54 motorists were booked for rash and negligent driving during the drive held on the direction of city police commissioner S Shyam Sundar.

Bus drivers were the top offenders when it came to rash driving. DCP K S Sudarsan told *TNIE*, "Based on the ground report, we decided to find frequent offenders. The licence of such drivers will be cancelled if they are found to have been committing offences frequently."
