**Sub: Notice for Sale of the Mortgaged Property**

1. We refer to our Demand Notice dated **16.09.2022** issued by us under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), wherein we had called upon you to pay the dues of **Rs.1,19,60,342/- (Rupees One Crore Nineteen Lakhs Sixty Thousand Three Hundred & Forty Two Only)** as of **12.09.2022** and future contractual interest till actual realization together with incidental expenses, cost and charges etc. in full within 60 days (Sixty days) from the date of the said notice (hereinafter referred as the "Outstanding Amount") and payable by you all pertaining to Loan Account Number **3515872, 12834430** financial facility disbursed by HDB Financial Services Ltd. (Hereinafter referred as HDBFS) within 60 days from the date of the said notice. You have since then failed and neglected to pay the amount as demanded.

2. It is pertinent to note that despite the service of the above mentioned notice you have failed to liquidate the outstanding dues and as such, the Authorised officer of HDB Financial Services Limited has taken actual possession of the properties described herein below in Annexure "A" (and referred hereinafter as "Secured Assets") through The Court Commissioner appointed by Chief Judicial Magistrate Solapur as per the order passed by the Honble CJM, Solapur (MH) in Cri.M.A No.53/2023 in exercise of the powers conferred on him under Section 14 of the Act.

3. After taking Physical/Actual possession of the secured asset, inspection was carried out by approved valuer in compliance of Rule 8(5) of the Security Interest (Enforcement) Rules, 2002. On the basis of report of valuer, Reserve Price for Secured Asset described herein below as mentioned in Annexure "A" is fixed at **Rs.64,13,150.25/- (Rupees Sixty Four Lakhs Thirteen Thousand One Hundred Fifty & Twenty five Paise Only)** for property **Schedule-I**, and Annexure "B" is fixed at **Rs.66,99,537/- (Rupees Sixty Six Lakhs Ninty Nine Thousand Five Hundred & Thitry Seven only for property Schedule-II).**

4. Hence, for recovering its legal dues, HDB Financial Services Limited has now proposed to again invite tender/conduct auction after fixing the reserve price.
