E - AUCTION SALE NOTICE

Whereas the **Borrower: Mrs.Manisha Dattatray Sangule**, W/o. Dattatray Ramchandra Sangule, **Co-Borrower: Mr.Dattatray Ramchandra Sangule**, S/o. Mr.Sangule Ramchandra, have borrowed money from Repco Home Finance Limited, **Pimpri Branch** against the mortgage of the immovable property more fully described in the schedule hereunder. 
payable at **Pimpri** or on the website **www.bankauctions.in** Tender form not in the prescribed format will not be accepted.

3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.
4. Offer without EMD and below the reserve price will be rejected.
5. The EMD amount shall be liable for forfeiture without any prior notice, if the successful/ bidder fails to adhere to the terms of sale.
6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interest bidding amongst themselves to enhance the offer price.
7. The successful bidder shall deposit 25% of the bid amount (inclusive of EMD) immediately after auction on the same day or not later than next working day of sale in cash or DD as above and the balance bid amount within 15 days from the date of confirmation of sale. 15. In compliance with Section 194 IA of the Income Tax Act, 1961 income tax @ 1% on the Reserve Price shall be deducted and paid under the PAN Number of the Purchaser. The bidder shall bear the 1% income tax on the bid multiplier amount and the Bank shall not take any responsibility for the same.
