# 'Aid deliveries to Gaza's 2.3 million people have been impeded by Israeli military restrictions'

## UN COURT SAYS ISRAEL MUST OPEN MORE LAND CROSSINGS

THE HAGUE

IN a legally binding order, the top United Nations court says Israel must open more land crossings into Gaza for food, water, fuel and other supplies.

The International Court of Justice issued two new so-called provisional measures Thursday in a case brought by South Africa accusing Israel of acts of genocide in its war in Gaza — charges Israel strongly denies.

The U.N. has reported that 100% of Gaza's 2.3 million people are at severe levels of food insecurity.

Aid deliveries have been impeded by Israeli military restrictions, ongoing hostilities and the breakdown of public order, according to the U.N. and international aid groups.

And in the West Bank, Israeli authorities say an attacker wounded three people Thursday after opening fire at several vehicles on a main route in the territory. The military says it's still searching for the shooter.

Tensions in the West Bank have surged since the start of the war in Gaza, which has killed more than 32,000 people and wounded 74,000, according to the Gaza's Health Ministry. The ministry doesn't differentiate between civilians and combatants in its tally, but says women and children make up two-thirds of the dead.

Some 1,200 people were killed in Israel and another 250 people abducted when Hamas-led militants

stormed into southern Israel, triggering the war in Gaza.

In a related development, an Israeli airstrike killed at least 12 people when it slammed into a residential building late Thursday in the southern Gaza city of Rafah, which is overflowing with displaced civilians, according to health officials.

Two children and four women were among the dead pulled from the rubble, said Dr. Saleh al-Hams, the head of the nursing department at the European Hospital.

Eight of the bodies, including two mangled and unidentifiable

corpses, were transferred to the European Hospital. The rest of the remains were taken to Abu Yousef al-Najjar Hospital, according to hospital records. After almost six months of war, about a dozen of Gaza's 36 hospitals are only partially functioning.

Israel has promised to launch a ground invasion of Rafah, saying the city on the border with Egypt is the last remaining Hamas stronghold in the Gaza Strip. Israelis have continued to bombard areas where they told civilians to take shelter including Rafah. AP

## Syria says Israeli attack in Aleppo killed many

BEIRUT

THE Syrian army says Israeli airstrikes early Friday near the northern city of Aleppo have killed and wounded several people and caused material damage. Syrian state media quoted an unnamed military official as saying that the Israeli strikes coincided with drone attacks by Syrian insurgent groups on civilians targets in Aleppo and its suburbs. It did not give an exact number for the casualties.

The UK-based Syrian Observatory for Human Rights, an opposition war monitor, said Israeli strikes hit missile depots for Lebanon's militant Hezbollah group in Aleppo's southern suburb of Jibrein near the Aleppo International Airport. It added that dozens of soldiers were killed or wounded in the strikes.

The Observatory said explosions were still heard two hours after the strikes. There was no immediate statement from Israeli officials on the strikes. Israel frequently launches strikes on Iran-linked targets in Syria but rarely acknowledges them.

On Thursday, Syrian state media reported airstrikes near the capital Damascus saying it wounded two civilians.

Hezbollah has had an armed presence in Syria since it joined the country's conflict fighting alongside government forces. Aleppo, Syria's largest city and once its commercial centre, has come under such attacks in the past that led to the closure of its international airport. Friday's strike did not affect the airport. The strikes have escalated over the past five months against the backdrop of the war in Gaza and ongoing clashes between Hezbollah and Israeli forces on the Lebanon-Israel border. In a related development, the Syrian army said an Israeli airstrike on a suburb of the capital Damascus wounded two civilians. AP
