

Rights panel summons CS over colleges not giving fee waivers

GR directed colleges to waive fees for students from drought-hit areas of state

TAKING COGNISANCE of colleges' non-compliance with a Maharashtra Government Resolution (GR) that directed reduction of fee waivers to students from drought-affected areas of the state, the Maharashtra Human Rights Commission has summoned the Chief Secretary and Principal Secretary from the Education Department to appear before the panel on May 13. The Commission has also sought that a written response along with supporting documents regarding this matter is submitted to a complainant. Kuldipee Ambekar, a social activist and lawyer had filed a complaint regarding the struggles faced by students who come from drought-affected areas of Vidarbha and Marathwada. Taking notice of their financial struggles, the government had sent out a GR on February 28 by the Directorate of Higher Education directing colleges to ensure that all students from drought-affected and drought-like areas are given an exam fee waiver. The Maharashtra HRC noted that "some educational institutions" were "not ready and willing to act as per GR and because of (that) the students, particularly from Marathwada and Vidarbha are suffering". The commission said it was the duty of the government to provide good education and other facilities to students and called the inaction on part of the government a violation of human rights of the students concerned. Ambekar said, "Students have been running from pillar to post for basic sustenance. Some of them are still trying to continue their education against all odds, but without the help that they were promised, they will end up dropping out. Despite the state government GR and regular follow-ups, many students have not been granted the required waivers from their colleges. Some had already paid their exam fee by the time the colleges started collecting data and then they were told that the amount will be sent to their accounts, but that has not happened either."

In Pune, bride donates blood before her wedding: 'The easiest way to help people'

MAY 5 was a big day for Manasi Hingde Dhanave, 25, a resident of Pashan in Pune, as it was her wedding day. She woke up early and reached a salon. Once ready, she headed straight, not to the marriage hall, but to a blood-donation camp in Baner. She chose to first donate blood and then head towards the wedding venue. While blood donation is not new for Dhanave, she said that by doing so on her wedding day, she wanted to send out a message. "I wanted to tell people that donating blood is the easiest way to help. One bag of blood, if used appropriately, can save the lives of five people. Also, there's a shortage of blood during the summers as very few donors are found in these months because of the immense heat. Wedding is a joyous occasion for a woman and doing such a good deed on the same day will make the day more prosperous and blessed," she said. The donation drive on May 5 was organised by NGO Vasundhara Abhiyan and inaugurated by Dhanave. Dhanave has finished her undergraduate degree in business administration in agriculture and her husband is a policeman attached to the Pune police. My husband and my in-laws were very supportive but could not come to the blood donation drive because of the pre-wedding rituals. However, my parents and cousins were there to support me," said Dhanave. Wasn't she anxious to reach the venue and worried that she may delay the function because of the donation camp detour? "Actually, we hadn't planned both these things to happen on the same day. But after I got to know that the drive was on the day of my wedding, I decided to go ahead, considering the message it would send out. The rituals were planned at 11 am, so I had to wake up early and rush to the camp. It was a great experience. It took about an hour at the donation camp but she managed to reach the wedding venue, where the guests were waiting for the bride and the groom to tie the knot, on time.

Archaeology dept director, asst director booked in bribery case

THE DIRECTOR and assistant director of Maharashtra Directorate of Archaeology and Museums were booked on May 7 after they were caught accepting a bribe of Rs 15 lakh, officials said. According to personnel of Anti-Corruption Bureau Nashik unit, assistant director Aarti Mrunal Alek (41) was caught taking the money from a 32-year-old man for providing a small business near the centuries-old Ramshef Fort in Nashik. She took the money at her residence on Tuesday. "Though she was caught red-handed, Alek was not arrested as she delivered a bribe eight days ago. She has been served a notice and directed to join the investigation," said Shambhoo Chhagan Walewarikar, Superintendent of Nashik ACB. During its probe, the ACB found that she was acting on the instructions of Tejas Madan Garge, director of the State Directorate of Archaeology and Museums. According to the ACB, the complainant wanted to start a small factory for his business of extracting oil from rubber tyres. But as the plant's location is close to Ramshef Fort, it was mandatory for him to first get a no-objection certificate (NOC) from the Archaeology Department. Nashik. He prepared an application for the same and forwarded it to the department. "Alek processed his application and sent it to the head office. She got all procedures done and also received the clearance to issue the NOC to the complainant," said an ACB officer. However, before handing over the NOC to the complainant, she demanded a bribe of Rs 1,50,000 on May 6. The complainant then approached ACB, which laid a trap and caught Alek on Tuesday. After the ACB ascertained her superior's role, Tejas Garge was also booked in the case. A probe revealed he was encouraging Alek to take bribe from the complainant, said an ACB officer. A case was registered against Alek and the Indiranagar police station in Nashik city.
