Suspect apprehended in Kasaragod child abduction, molestation case

Arrested from kin's house, he awaits DNA examination results to confirm involvement in crime

A MAN has been taken into police custody in connection with the abduction and molestation of a ten-year-old girl in Kasaragod. The special investigation team (SIT) apprehended the suspect at a relative's house and is currently awaiting DNA examination results to confirm his involvement. The suspect was identified based on clues from CCTV footage, which is now circulating on social media. The footage shows the suspect walking towards the child's house on the morning of the incident.



The probe is being led by DIG Thomson Jose and District Police Chief P Bijoy, with a 20-member team, including four DYSPs, working on the case. Earlier, three local drug ped-

The police have conducted an extensive search of around 400 houses in connection with the case. The search operation, which began on Thursday morning and continued until evening, covered coastal areas,

railway tracks, and fields. Local residents joined the police in the search efforts, working throughout Wednesday night in groups led by one or two policemen.

The search and investigative activities in the area were headed by Kanhangad DySP V V Lathesh. Key members of the team included Assistant Commissioner of Kannur Crime Branch Balakrishnan Nair and Assistant Commissioner of Kannur City Narcotics Cell C K Sunil Kumar. Balakrishnan Nair tracked and interrogated over 100 people in connection with the incident. Sunil Kumar reviewed footage from over 200 CCTV cameras. House investigations were led by Inspector M P Azad and SIs M T P Saifuddin and T Haridas.

Some leaders swindled LS poll funds, says Rajmohan Unnithan

SENIOR Congress leader and Kasaragod MP Rajmohan Unnithan has accused some leaders of the party of embezzling the Lok Sabha election funds. Rajmohan Unnithan said that some constituency committee presidents swindled the money that was allotted to both committees to meet poll expenses in Kasaragod Lok Sabha constituency.

He raised the allegation at a programme held at the Kasaragod DCC office that recent Lok Sabha Election funds from the Congress party were embezzled

by some party leaders. Rajmohan Unnithan said he knew the people who swindled the money. He also alleged that many people tried to defeat him in the election.

"Some people swindled the money I gave for the election work without giving it to the booth committees. I have noticed those constituency presidents. I had already given separate money to the constituency presidents for the elec-

tion. I had given enough money to the block committees and the UDF constituency committee. The money allotted to the booth committees should have been spent at booth levels. No one is allowed to take that money away," said Rajmohan Unnithan.

Student found dead in college hostel room

A 19-YEAR-OLD student was found hanging in the hostel room of EK Nayanar Polytechnic College in Trikaripur, Kasaragod, on Friday. The deceased is Abhijith Gangadharan, a native of Bhimanadi, Kasaragod.

Abhijith was a first year computer science student at the college. The incident came to light when one of Abhijith's classmates came to collect the hall ticket for the ongoing examinations from him.

Despite knocking several times, Abhijith did not open the door. As his phone was also switched off, the classmate alerted others in the hostel.

When the hostel mates

opened the window to check on Abhijith, they found him hanging from the ceiling fan. The college authorities immediately reported the incident to the police.

The Chendera police reached the spot after getting the information. After a postmortem examination, the body was handed over to Abhijith's relatives.

"We have got information that Abhijith was having an affair with a girl in the college. The girl's refusal to continue the relationship might have led him to take the extreme step. As there is no suicide note, we are not able to confirm the reason. We have launched a detailed investigation into the incident," said an officer with the Chendera police station.
