

Was an honour to be your voice in Parliament: Rahul writes to Wayanad

SENIOR CONGRESS leader Rahul Gandhi on Sunday wrote to the people of Wayanad and said that he is sad about vacating the Wayanad constituency, but is consoled because sister Priyanka will be there to "represent the constituency's people".

On June 17, the Congress had announced that Rahul Gandhi will vacate Wayanad and retain Rae Bareilly, with party general secretary Priyanka Gandhi Vadra to contest the Wayanad seat. Rahul had won both seats in the

recently concluded Lok Sabha polls and had to vacate one of them. In an open letter, Rahul said, "I met you five years ago. The first time I visited you, I came asking for your support. I was a stranger to you and yet you believed in me. You embraced me with unbridled love and affection. It didn't matter which political formation you supported, it didn't matter which community you were from or which religion you believed in or which language you spoke."

"I am sad, but I am consoled because my sister Priyanka will be there to represent you," he wrote in the letter.

Prajwal's brother Suraj Revanna held for 'sexual assault' of JDS worker

THE KARNATAKA Police on Sunday arrested Janata Dal (Secular) MLC Suraj Revanna, brother of rape accused former MP Prajwal Revanna, for allegedly sexually assaulting a man.

The man, a J(DS) worker, said in his complaint that he had visited Suraj at a farmhouse in Karnataka's Hassan district on June 16. According to the FIR, Suraj allegedly stripped and sexually assaulted the complainant, and also threatened to kill the man's family. The complainant also alleged that Suraj assured

him of a job and political growth.

Karnataka Home Minister G Parameshwara said Sunday that the case has been handed over to the state Criminal Investigation Department (CID). Police on Saturday booked

Suraj and a close aide Shivakumar under IPC sections 377 (carnal intercourse against the order of nature), 342 (wrongful confinement), 506 (intentional insult to provoke breach of the peace) and 34 (common intention).

Shivakumar had earlier filed an extortion case against the complainant, alleging that he had demanded Rs 5 crore and later settled for Rs 2 crore.

The complainant, however, said it was Shivakumar who offered him Rs 2 crore to keep the matter secret.

Before filing the case, the man had also written to Home Minister Parameshwara and the state police chief.

EAM recalls Kanishka bombing after Canada's tribute to Nijjar

DAYS AFTER the Canadian Parliament paid tribute to pro-Khalistani terrorist Hardeep Singh Nijjar, External Affairs Minister S Jaishankar on Sunday recalled 1985 Kanishka bombing in a social media post, saying that it was a reminder why terrorism should not be tolerated.

"Today marks the 39th anniversary of one of the worst acts of terrorism in history," Jaishankar said. "Pay my homage to the memory of the 329 victims of AI 182 'Kanishka' who were killed

this day in 1985. My thoughts are with their families. The anniversary is a reminder why terrorism should never be tolerated." The Indian consulate-general in Vancouver has announced plans to hold a memorial event for the victims of the 1985 Air India Kanishka flight bombing.

"India stands at the forefront of countering the menace of terrorism and works closely with all nations to tackle this global threat. 23 June 2024 marks the 39th Anniversary of the cowardly terrorist bombing of Air India flight 182 (Kanishka), in which 329 innocent victims, including 86 children, lost their

lives in one of the most heinous terror-related air disasters in the history of civil aviation," the consulate-general posted on X.

The memorial service is scheduled to take place on June 23 evening, at the Air India Memorial located in Stanley Park's Ceperley Playground area in Vancouver. "The Consulate General of India in Vancouver encourages members of the Indian Diaspora to attend, demonstrating solidarity against terrorism," the post read.

The RCMP also issued a statement, which caused the "great est terror-related loss of life involving and affecting Canadians" in the country's history.
