Calicut Football Club to represent Kozhikode in Super League Kerala

To participate with five teams from Kannur, Malappuram, Thrissur, Ernakulam, T'Puram

KOZHIKODE district's new football club, Calicut FC, will be part of the forthcoming Super League Kerala (SLK) scheduled to be held on September 1 in Kochi. Calicut FC, owned by the IBS Group, will represent the district in SLK, the men's franchise football league organised by the Kerala Football Association, along with five other districts- Kannur, Malappuram, Thrissur, Ernakulam and Thiruvananthapuram. The official logo of the team was released on Saturday in Kozhikode by M K Raghavan MP in the presence of Kerala Football Association president Navas Meeran and franchise owner of the club V K Mathews, who is also the executive chairman of IBS Group.

On the occasion, Navas said the association aims to ensure a steady remuneration and more salaried career in the field of football for the players trained under the training cen-

lines as the Indian Super League, will be the premier sporting event in Kerala. Thirty matches will be played in the preliminary rounds, with each team participating in ten matches (five at home ground and five away). The top four teams will advance to the play-off stage.

Calicut FC will comprise 25 players, six of whom are from overseas, while the rest are from India (of which 12 are from Kerala). The head coach will also be from overseas. The home ground for Calicut FC will be the Kozhikode Municipal Corporation Stadium.

Mathews said "Kozhikode is the epicentre of football frenzy as witnessed during the last World Cup. Several Keralites have represented India in the past and Kerala entered the finals of the Santhosh Trophy for seven consecutive years from the late 1980s to mid-'90s. We need to regain our past glory and hope to achieve this by giving international exposure to the budding talents in the state. There is no better way to start this than by having a new professional football team for Kozhikode."

'KAFIR' SCREENSHOT

Register case against ex-MLA, says Shafi

VADAKARA MP Shafi Parambil has urged the Vadakara police to register a case against former MLA K K Lathika for allegedly circulating the controversial 'Kafir' screenshot. At a press meet at Kozhikode railway station on Saturday, Shafi told the media that police are still hiding facts regarding the screenshot controversy. Alleging that the CPM is aware of the source of the screenshot, Shafi said that the blame, however, falls on the UDF. Shafi's reaction was based on a report submitted by the Vadakara police, which says that Youth

League leader Muhammad Khasim has no connection with the screenshot.

The controversy involved a screenshot that called LDF candidate in Vadakara K K Shailaja a 'kafir' (non-believer) while seeking votes for UDF candidate Shafi Parambil on behalf of his religion.

He said by circulating the fake screenshot, Lathika was trying to create communal polarisation in Vadakara. "CPM had tried to attack the face of unity of people in Vadakara by using the screenshot. Their leadership should apologise to their workers for making them believe that UDF created the screenshot" he said.

6 eateries near Kozhikode beach closed for violating norms; raids to continue

AFTER A recent inspection, the food safety department and the health wing of the Kozhikode municipal corporation closed down six shops located near the Kozhikode beach. The inspections were initiated to assess the current conditions at the eateries, which had previously received caution notices for various violations. This intensified scrutiny by the department was prompted by a series of foodborne illness outbreaks and incidents of jaundice in the city.

The operation targeted 16 shops on the Kozhikode beach, resulting

in the closure and imposition of fines on six of them. Sakeer Husain, assistant commissioner of the food safety department in Kozhikode, said that during earlier inspections, it was observed that uncovered fruit slices were left exposed to dust, attracting flies and posing a risk for the spread of diseases. "Subsequently, notices were issued to all eateries on the Kozhikode beach to ensure proper covering of fruits and other food items. While many shops adhered to the instructions, it was found that some failed to comply with the directives. As a result, the uncovered fruits, ice, and other perishables

were discarded during the inspection," he said.

As a preventive measure to curb the further spread of infectious diseases such as jaundice, viral hepatitis, leptospirosis, and dengue fever, the sale of the renowned 'Ice Urathi' was temporarily banned on the beach premises. The officials stressed that ongoing inspections will continue, and necessary action will also be taken to address the unauthorised sale of roadside food and drinks. Furthermore, restaurant owners in the city have been urged to ensure the quality of drinking water by utilising government labs to prevent the spread of communicable diseases like jaundice.
