Israel wants Gaza City evacuated amid heaviest combat since Oct 7

UN office used by Hamas attacked; 60% of militants eliminated

GAZA/JERUSALEM

ISRAEL's army dropped thousands of leaflets over war-torn Gaza City on Wednesday urging all residents to flee a heavy offensive through the main city of the besieged Palestinian territory.

The leaflets, addressed to "everyone in Gaza City", set out designated escape routes and warned that the urban area, which had a pre-war population of over half a million, would "remain a dangerous combat zone".

The warning came as Israeli troops, backed by tanks and aircraft, have fought Hamas and Islamic Jihad militants in the heaviest combat the city has seen in months in the war raging since October 7.

In one operation, the army said it had killed militants and found weapons inside the long-evacuated Gaza City headquarters of the UN agency for Palestinian refugees, UNRWA.

The Israeli military said that one overnight attack in Gaza City targeted Hamas and Islamic Jihad targets operating from inside the headquarters of the UN agency for Palestinians UNRWA. The UN agency has not had control of the building since October. Israeli forces said in February they had found a Hamas tunnel under-

neath the headquarters.

The military said the militants were "operating inside UNRWA's headquarters in the area and using it as a base to conduct attacks on IDF (Israeli Defense Forces) troops in the central Gaza Strip". It said that militants had been "eliminated" and "large amounts of weapons" found.

Elsewhere across Gaza, deadly strikes have hit four schools used as shelters in four days, sparking rebukes from France and Germany which both 1 belled the

attacks "unacceptable".

Heavy fighting also raged in Gaza's far-southern Rafah, where Israeli tanks had rumbled into the city centre and unleashed intense fire on buildings.

The latest fighting in Gaza has newly displaced 350,000 civilians, said UNRWA chief Philippe Lazzarini, who spoke before the leaflet drop and said "there is absolutely no safe space in Gaza".

One woman carrying her scant belongings through the ruins, Nimr al-Jamal, said on

Tuesday that "this is the 12th time" her family has had to flee. "How many times can we endure this? A thousand times? Where will we end up?"

The upsurge in fighting, bombardment and displacement came as talks were to resume in Qatar towards a truce and hostage release deal to end the war now grinding on into its 10th month.

An Israeli delegation led by Mossad chief David Barnea arrived in Doha. CIA director William Burns was also expected in the Qatari capital. *AFP*

Syria national airline resumes Saudi flights after 12 years

RIYADH

SYRIA's national airline resumed regular services to Saudi Arabia after a 12-year suspension on Wednesday as the first flight arrived in Riyadh.

The move, announced by Syrian Airlines continues a slow rapprochement between the two governments who restored diplomatic relations last year.

Syrian Ambassador to Saudi Ayman Soussan said a Syrian Airlines plane carrying 170 passengers touched down in the Saudi capital, marking the resumption of a regular route.

He said the two countries have agreed to "operate one round-trip flight per week between Riyadh and Damascus" after the long pause prompted by Syria's civil war.

Syrian transport ministry official Suleiman Khalil said the direct route could be expanded to cover airports in the Saudi cities of Jeddah and Dammam, depending on demand.

Passenger flights between the two countries were halted in 2012 when Riyadh severed ties with Damascus over President Bashar Assad's brutal crackdown on anti-government protesters at the start of the country's civil war. *AFP*

Strategic cooperative ties between China, Bangladesh

CHINA and Bangladesh are reaffirming their ties during a visit by Bangladesh Prime Minister Sheikh Hasina to Beijing on Wednesday as tensions rise in the region over territorial disputes and resources.

China's official *Xinhua News Agency* quoted Wang Huning, a member of China's Politburo Standing Committee who met with Hasina, as saying that "China and Bangladesh have respected and treated each other with equality, setting a good example of friendly coexistence and mutually beneficial cooperation between countries." *Xinhua* reported Hasina later met with Chinese President Xi Jinping and "elevated their relations to a comprehensive strategic cooperative partnership." No details were given, but the designation of relations generally entails closer economic relations, largely funded by Chinese policy banks.

Bangladesh occupies a strategic position between Myanmar, a longtime Chinese ally now wracked by internal conflict, and India, the rising Asian giant with which China has a longstanding border conflict. Hasina met with her Chinese counterpart, Li Qiang, on Wednesday and oversaw the signing of 28 bilateral agreements covering mostly

trade and investment.

While Bangladesh maintains development partnerships with the United States and India, it is also drawing closer to China, which is heavily engaged in the country's major infrastructure projects.

Hasina is eager to strengthen relations to encourage Chinese investment in her country's economy, which faces challenges over a heavy debt burden. China also provides Bangladesh with tanks, missile launchers and other weapons and is building seaports, railway tracks, power plants and bridges. The US remains Bangladesh's largest source of foreign direct investment.

Media reports in Bangladesh say it will seek \$20 billion in new loans from China during Hasina's visit. Hasina's visit to China is taking place a few weeks after she visited India.

Trump wants second debate, golf match; no, says Biden campaign

WASHINGTON

DONALD Trump, the Republican presumptive presidential nominee, has offered his rival and incumbent President Joe Biden the opportunity to "redeem himself in front of the entire world" via a debate this week while also challenging him to a round of golf.

Trump's challenges to Biden came as he was feeling quite confident after his maiden debate performance against the president late last month.

"I'm officially offering Joe the chance to redeem himself in front of the entire world," Trump, 78, said at a campaign rally in Florida.

"Let's do another debate this week so that sleepy Joe Biden can prove to everyone all over the world that he has what it takes to be president," he said.

Biden, the Democratic nominee, performed poorly at the June 27 presidential debate in

Atlanta, after which even his own party colleagues are asking him to drop from the race. Biden has rejected such calls.

At the same rally, Trump then challenged Biden to an 18-hole golf match.

"I'm also officially challenging Joe to an 18-hole golf match right here," he said.

"If he wins, I will give the charity of his choice, any charity that he wants, \$1 million. And I'll bet you he doesn't take the offer. What that match will do is prove that Joe is, in fact, all talk and no action," Trump said.

The Biden campaign has rejected both the challenges.

"Joe Biden doesn't have time for Donald Trump's weird antics he's busy leading America and defending the free world. Donald Trump is a liar, a convict, and a fraud only for himself par for the course," Biden-Harris 2024 Spokesperson James Singer said. *PTI*

2 Indian origin men sentenced for fraud

SINGAPORE: Two Indian origin men were sentenced to jail for scamming victims in the United States through at least 50 companies, two of which received money through bank accounts, including transactions from China and the UAE. Ishan Sharma, 34, was sentenced to four weeks' jail. He pleaded guilty to two charges under the Companies Act after instigating his friend Kandhban Letchumanansamy, 36, into not exercising reasonable diligence when the latter was a director at both firms. *The Straits Times* reported. *PTI*
