**Patient dies in hospital, family creates ruckus**

After the death of an elderly patient on Friday at Apple Hospital located in Bhanwar-kuan police station area, the relatives of the deceased created a ruckus at the hospital premises.

They alleged that stents were put in his heart without doing angiography due to which the patient died. After the death of the patient, the doctor who operated on him also fled away from the hospital.

The deceased's relatives Rishabh and Rinku Hardia said that the health of Dinesh Mau-

rya (58) a resident of Ganesh Nagar suddenly started deteriorating in the afternoon. He was having chest pain and was also sweating.

At first, they took him to the hospital near their house. From there, he was brought to Apple Hospital for treatment. Here the doctors told that there is a lot of blockage in Dinesh's heart.

After this, they put the stent without doing angiography and completed the operation in 10 minutes. After this, he was shifted to ICU where he died during treatment, they alleged.

Dinesh's relatives alleged that Dinesh was fit to walk

while coming to the hospital, but after coming to the hospital his health deteriorated and he was admitted.

They also blamed Dr Dev-

endra Chaurasia that due to his negligence Dinesh died and he gave wrong treatment to him.

According to Bhanwar-kua Police Station in-charge Rajkumar Yadav, police have registered a death-incident. Post-mortem of the body will be done after which more clarity will come in the case.

On receiving the news of death, a large number of people known to Dinesh gathered at the hospital and created a ruckus. After this, ADM, SDM and police force also reached the spot. The officials assured action, after which the relatives stopped the ruckus.

**Man booked for abetting wife to commit suicide**

**Indore:** Lasudia police registered a case against a man for abetting suicide of his wife, an official said on Friday. The woman hanged herself at her place on May 11 after being fed up with domestic violence and physical assault of her husband. According to the police, one Shankuntla Chauhan hanged herself on May 11 at her place in Mahalaxmi Nagar area. During investigation and after recording statements of the woman's family members, it came to light that domestic disputes used to occur between the couple on a regular basis. Her husband Sunil Chauhan used to physically assault her regularly.

**Property dealer dupes 6 of Rs 43L, on the run**

A man working as a property dealer allegedly duped six persons to the tune of Rs 43 lakh in Katara Hills, the police said on Friday. The search is on to trace the accused.

Investigating officer (IO) at Katara Hills police station Savita Vasudev told Free Press that resident Sanjay Singh, along with five others, submitted a written complaint to the police on Friday. They alleged that they had purchased plots from property dealer

Mahesh Meena who avoided registering the sale deed. Meena also refusing to return their money. When police contacted Meena over phone, he said he had purchased land from Narayan Patidar at a cost of Rs 9.60 crore. He added that he was unable to provide money to Patidar owing to which his agreement with him ended. When police asked Meena to return the money, he refused, after which the police registered an FIR against him. They said they have launched a manhunt to nab Meena who is on the run.

**Rs 30 lakh demand to return original documents challenged in High Court**

Demand of Rs 30 lakh to return original documents, as seat leaving bond condition for Post Graduate medical, has been challenged in High Court, Indore. Shubhangini Raj, PG Medical student and resident of Katni, has filed petition in High Court bench, Indore.

The petitioner was granted admission in MGM medical college Indore on November 29, 2022 in the course of post-graduation anatomy in the mop-up round and the petitioner deposited all the documents but she could not pursue the course of anatomy because of various circum-

stances. Now, after completion of 2 years, the petitioner wanted her documents back but she has been informed that until and unless she pays Rs 30 lakh as a seat leaving condition as per the rules, she will not get back documents.

Aditya Sanghi, counsel for the petitioner, said, "More than two years have passed and now the petitioner will again have to appear in post-graduation entrance examination Pre-PG in June/July/August, 2024 and therefore, she went to MGM Medical College, Indore and requested the authorities concerned that she should be given the original certificate."

According to rules, the same licence cannot be used to sell seeds from different places, but the traders are violating the rules.

The officials of the agriculture department cancelled the licence of Akash Agro Industries for illegally storing seeds in the Bherunda area. Sub-divisional officer of revenue block in Bherunda presented the physical verification certificate of Akash Agro Industries located near the bus stand and inquiry report about the firm.

In the inquiry, it came to light that the farm stored 125 quintals of Moong (green
