

Posters seeking Cong district prez's resignation appears at party HQ

Thankappan faced criticism for not engaging actively in Alathur Lok Sabha poll campaigns

THE factionalism within the Palakkad district Congress committee is out in the open as posters demanding resignation of DCC president A Thankappan were found on the walls of the party headquarters here early Sunday morning.

Following the defeat in the Lok Sabha elections in the Alathur constituency, the A/I factions within the party accused district leaders of inadequate intervention during the election period.

Thankappan faced heavy criticism for purportedly not actively engaging in the Alathur campaigns during a subsequent meeting.

Congress's Remya Haridas lost to CPM's K Radhakrishnan by a margin of 20,111 votes.

Posters against the DCC president appeared in the city soon after the election results were announced.

The poster row comes at a time when political parties began preliminary work for the upcoming by-election to the Palakkad assembly seat, which was previously represented by

Congress leader Shafi Parambil who now represents Vadakara constituency in the Lok Sabha. "The party's state-level leadership is yet to finalise its candidate in Palakkad. However, there are discussions about selecting a youth leader from outside the district as the first choice. This has led to internal discord within the party, with some members demanding a local leader as the candidate to ensure a balance of power among the factions. During a recent DCC meeting, a member even proposed a resolution against considering candidates from outside the district," said a party source.

TEEN DIES OF VIRAL HEPATITIS IN MALAPPURAM DISTRICT

ONE more death has been reported in Malappuram due to viral hepatitis on Sunday. The deceased is Dilsha Sherin, 15, of Chelembra, who was under treatment at a private hospital in Kottakkal.

Chelembra panchayat authorities said that 63 viral hepatitis cases have been recorded in the local body so far. "The girl was diagnosed with viral hepatitis last Friday but succumbed to the disease on Sunday morning. The condition of other patients with the disease is not critical," said panchayat president Sameera.

The sudden outbreak has been linked with a wedding ceremony held at an auditorium in Moonniyur panchayat on May 16.

The food and water served at the wedding caused the disease in many people. As neighbour of Dilsha was also infected by consuming contaminated water from the event. The 15-year-old may have contracted the

disease from the neighbour. Most of the infected people are from Paingottor and Pullippuramb areas in Chelembra panchayat.

Panchayat authorities have initiated measures to prevent the spread of the disease since the first report of the infection in May.

"We have taken measures to create awareness about the disease among people. We distributed leaflets containing information about the symptoms, preventive measures, and other details. Additionally, we chlorinated wells and other water bodies in the area. Efforts to prevent the spread of the disease will continue," said Sameera.

In Vallikkunnu, 293 people have been infected, most of them primarily and secondarily from the wedding. Vallikkunnu panchayat president Shylaja said that none of the infected are in a critical condition.

"We conducted a camp to identify the viral hepatitis patients and found that most of them had attended the wedding ceremony at Moonniyur," Shylaja said.

Country-made bomb explodes at Chavakkad, youth arrested

CHAVAKKAD police arrested a youth in connection with an explosion of a country-made bomb near Muthanmavu Junction in Orumanayur on Sunday. The arrested is Masthan Shafeeq. According to locals and sources with the police, the incident occurred around 2.30pm.

"We heard a loud explosion and saw smoke spreading on the Sakha Road. We also noticed glass pieces, stones and an explosive object wrapped in cloth," said a resident. Fortunately, no one was injured in the explosion.

Later, the bomb squad from Thirissur visited the spot, inspected the accident area and collected samples as part of investigation procedures.

Shafeeq, who has over 20 criminal cases against him in the Thirissur City Police limits, lived in Manuthy and shifted to Orumanayur two years ago.

Police said the accused had made the bomb at his house. "On Sunday, he threw the bomb on the road after a quarrel with his mother for keeping bombs at their house. The accused was highly inebriated and is yet to cooperate with the interrogation. His arrest will be recorded at the earliest," the police added.

Guruvayur temple withdraws decision to enforce darshan restriction

Thirissur: The Guruvayur Devaswom Board has informed the withdrawal of VIP/special darshan restrictions that were supposed to be enforced on the Udayasthama Pooja days starting July 1 at the Guruvayur Sree Krishna temple. The decision comes in light of the manageable crowd of devotees. However, restrictions will still be in place on public holidays. On these days, the temple will open at 3:30pm to accommodate more devotees, informed the administration.

Woman found dead in well in Wayanad

Kalpetta: A woman was found dead in a well in Wayanad on Sunday. Meena, 42, a native of Pozhuthana, was found dead inside the well near her house. Meena's relatives informed the police that she had been missing for the past two days. Vythiri police registered a case of unnatural death and launched an investigation. As per the primary investigation, it is found that Meena used to get into fight with husband Narayanan. Meena's son found the body on Sunday. Meanwhile, Narayanan is absconding.

Four hurt in fox attack in Kozhikode; 1 critical

Kozhikode: An attack by a fox has left four persons injured, one of them grievously, at Modakallur in Kozhikode. The fox died later, sparking concerns of rabies infection. Three of the victims were bitten by the fox on the premises of their houses. All the victims, including the one who is critical, are being treated at the Kozhikode Medical College Hospital. Though local residents managed to capture the fox, it died later. A postmortem of the wild animal is planned on Monday to verify whether it was infected with rabies or not.

Wild jumbo with injured leg tranquillised in Mannarkkad

FOREST officials on Sunday morning administered tranquilisers to a wild elephant found with an injured leg at Thiruvazhiyode in Kottopadam village near Mannarkkad.

It is learnt that the forest rangers are monitoring the jumbo, which is estimated to be around 10 years old. Local residents spot-

ted the elephant in the Karadiyode area and promptly alerted the forest department as the animal remained stationary.

Upon inspection, forest guards observed the leg injury and summoned forest veterinary surgeon Dr David Abraham, who arrived at the scene to oversee the treatment procedures. Efforts are underway

to provide medical care to the elephant once it is sedated, with plans to relocate it back into the forest once it has fully recovered. Officials said the elephant was found roaming in the inhabited area over the past few days.

Mannarkkad forest range officer N Subair, Thiruvazhamkunnu deputy range forest officer K Sunilkumar, local police, and members of the rapid response team (RRT) were present at the spot.
