

Madras HC sets aside ex-Minister's conviction in rioting case

The Madras High Court on Wednesday set aside the conviction and three-year sentence imposed by a trial court in 2019 on the then Youth Welfare and Sports Development Minister, P. Balakrishna Reddy, in a 1998 case of rioting related to protests against illicit ar-rack in Krishnagiri.

Justice G. Jayachandran allowed the appeals preferred by the former Minister and 15 other convicts against the verdict passed by a special court for MP/MLA cases in Chennai in January 2019, holding that the trial court had erred in convicting them despite a lack of credible evidence. "On a cumulative assessment of the evidence, this court finds several lacunae in the prosecution case and those lacunae enure to the benefit of the accused persons. The trial court, unfortunately, failed to note that the prosecution was unable to even ascertain the identity of the accused persons who had gathered for the protest and formed an unlawful assembly. It convicted them at random based on the weak and uncorroborative evidence," the judge wrote. The conviction of the then Minister by the trial court created ripples in political circles in 2019, as he faced disqualification from continuing in the AIADMK Cabinet due to being sentenced to more than two years.

Andhra Pradesh Chief Minister N. Chandrababu Naidu has asserted that he will rebuild the capital city in the quickest possible time by removing the hurdles in its path, including legal, one by one and striving to restore the much-needed investors' confidence.

Releasing a White Paper on "Amaravati - The people's capital" at a media conference on Wednesday, Mr. Naidu said that he has to consult the Singapore government to see if it would collaborate with the State government again in taking the capital project forward under the changed circumstances. "Bringing them back is not so easy as they have ap-

parently lost confidence in the Andhra Pradesh government. Who would risk their money on projects like ours? They would lend their expertise to several other countries and States (like A.P.) in the world. Here is a situation where international governments and potential investors will ask what guarantee can we

give that everything will be fine, after having a bad experience in the last five years. We need to introspect if such persons (like former Chief Minister Y.S. Jagan Mohan Reddy) should occupy a public office ever," he said.

Centre's cooperation Mr. Naidu said he would

seek the Union government's cooperation to rebuild Amaravati and exuded confidence that the expected support would come.

The Centre had provided capital gains exemption for all sales of land and released ₹1,500 crore of the approved ₹2,500 crore for Amaravati.

The TDP government invited tenders worth ₹41,170 crore between 2014 and 2019 and all the works were grounded. A sum of ₹4,319 crore was paid and the payables as on date stood at ₹1,269 crore.

Mr. Naidu said the YSR Congress Party (YSRCP) government "ruined everything and the present government was in an unenviable situation because of it".

A.P. CM must convince Centre for special status'

CPI Andhra Pradesh secretary K. Ramakrishna on Wednesday said this was the "right time" for Chief Minister N. Chandrababu Naidu to insist on the Centre to extend Special Category Status to Andhra Pradesh. The CPI leader was in the city as part of the three-day CPI State Council meeting.

The sale of the assets of Visakhapatnam Steel Plant (VSP) by the Centre is a part of its larger ploy of sell the plant, he said.

Mr. Ramakrishna recalled that the trade unions and the Left parties had been staging protests in all the districts against the privatisation. He said the CPI national council meeting to be held in Delhi from July 11 to 15 would also discuss the Visakhapatnam steel plant issue.

Mannar murder: police record arrest of three persons

The police on Wednesday recorded the arrest of three persons in connection with the murder of Kala, a young woman, at Mannar in Alappuzha 15 years ago.

The arrested have been identified as Jinu, Soman and Pramod. The FIR registered by the Mannar police has named Anil Kumar, former husband of Kala, as

the first accused. He is reportedly working in Israel. Authorities said steps had been initiated to bring Anil Kumar back from Israel.

Kala, 27, of Mannar went missing in 2009. According to the FIR, Anil Kumar, along with the three arrested, all relatives of the former, murdered Kala on the Vailiyi Perumpuzha bridge in 2009. They transported her body in a car before burying it at an unidentified location and destroy-

ing evidence. The FIR, however, did not mention the date of the crime and the place where the body was buried.

Murder confirmed On July 2, the police team, investigating the case recovered some materials, including likely human body parts, from a septic tank in the compound of Anil Kumar's house at Mannar. District Police Chief (DPC) Chaitra Teresa John later

confirmed that the woman was murdered. The police, a couple of months ago, launched a probe into the woman's missing case after receiving an anonymous letter at the Ambalappuzha police station stating that Kala was murdered.

Officials said the FIR was registered based on a complaint filed by Suresh Kumar J.V., a relative of Anil Kumar. Mr. Suresh, who was taken into custody along with the arrested,

reportedly divulged to the investigators that after committing the murder, Anil Kumar sought his help to bury the body. He, however, rejected the demand. On the reason for the delay in reporting the crime by the complainant, the FIR noted that Mr. Suresh "feared the first accused (Anil Kumar)". The Judicial First Class Magistrate Court, Chengannur, sent the arrested in police custody for six days.
