BUSTING OF FAKE CALL CENTRE

Fraudsters used fake letters of US agencies to threaten victims: Cyber cell in court challan

THE CYBER fraudsters who duped a number of US citizens by running a fake call centre also used fake letters of various US law enforcement agencies to threaten their victims so that they could get money from them. The fake letters, recovered from the laptops of the accused, were attached with the challan presented in the court by the State Cyber Cell.

The recovered fake letters include letters of Social Security Administration, Department of Treasury and Federal Trade Commission. The letters were allegedly copied by the culprits from the websites of the US agencies so that they could threaten their targets in case they refused to give them money.

In one such fake letter of Social Security Administration, the culprits told the victim that

his social security number has been compromised due to the identity theft.

The letter read, "This letter is to inform you that your SOCIAL SECURITY NUMBER is compromised as you are a victim of an identity theft. So we are going to suspend it for a temporary period. And as per FEDERAL Government Law as you are a victim of identity theft (18 U.S.C 1028) and there are criminal charges of MONEY LAUNDERING ACT of 1986 (18 U.S.C). Hence, you are not allowed to keep more than \$1500 in your account. Any amount greater than \$1500 would be frozen once the social security number is suspended. So, kindly safeguard your genuine account before we suspend your current Social Security Number or else it will be frozen till the entire investigation is completed. In order to safeguard your true belonging asset you will be facilitated with the International

Federal account for the next 3 to 5 working days, where you can go ahead and secure your legitimate financial belongings."

The letter further read, "PRIVACY ACT STATEMENT, Sections 205(c) and 702 of the Social Security Act, as amended, allow us to collect this information. Furnishing us this information is voluntary. However, failing to provide all or part of the information may prevent us from assigning you a Social Security number (SS) and issuing you a new or replacement Social Security card."

In another fake letter of Federal Trade Commission which was recovered from the laptops of the accused, the culprits threatened the victims that they were behind the fraudulent activities.

The letter read, "During investigation we came to know that you are not behind these fraudulent activities going on under your name so we need to suspend your Financial, Assets

on immediate basis so kindly follow the necessary steps provided to you by the FTC (Federal Trade Commission) appointed for your case and you need to verify all of your income from all the bank accounts claiming yourself towards the federal court house until the registration is completed under your newly allotted identity, while we check it out and until we close the case.

We need your cooperation to prove that the financial assets which you hold under your name are legally yours and you have no relation with this crime."

The Federal Trade Commission Act (FTC Act) prohibits unfair or deceptive acts or practices in or affecting commerce.

The letter read, "There are four different types of privacy protection physical, virtual, third-party and legislation. We are writing to inform you that your Identity has been compromised."

FORMER MD of Google Parminder Singh has revealed how drinking just one peg of gin and tonic had affected his sleep quality, as recorded by his Garmin watch. Writing on a micro-blogging site, he detailed how his data showed that the crucial rapid eye movement (REM) phase, during which the brain rests and repairs itself and during which emotional experiences are processed and memories are consolidated, was compromised by alcohol.

Singh posted data to show that alcohol reduced his REM time to 18 minutes while it lasted an hour and four minutes on a normal sleep day. To wake



up alert and fresh, an adult needs seven to nine hours of sleep with the REM phase, usually in the latter half of the sleep cycle, swinging between an hour-and-a-half and a little over two hours.

What is REM sleep and how does alcohol reduce it?

REM is the most restorative part of your sleep cycle. It stimulates areas of the brain that deal with learning and memory. If its duration is shortened, it can leave you feeling tired even after a full night's sleep. If you drink alcohol close to bedtime, then it can cause more frequent awakenings during the night leading to sleep fragmentation. It can trigger snoring and sleep apnea, which impacts heart health over the long term.

On 27 August 1988, Inspector Ram Avtar led a raid with 15 personnel in two vehicles. Upon hearing gunfire, they proceeded to village Chan Chak, where they learned that 3-4 terrorists were hiding in the house of an ex-Sarpanch. They cordoned off the house, and Inspector Ram Avtar, along with others, entered through the rear door. Challenging the terrorists, he was fired upon, with bullets striking his bulletproof jacket. He returned fire, killing one terrorist, but was fatally wounded by a burst of bullets to the neck. For his gallant action, he was posthumously awarded the President's Police Medal for Gallantry.

Despite this, the troopers bravely fought back, forcing the Maoists to flee. However, four brave soldiers—Shaheed HC Saligram Yadav, Shaheed Lnk/FTR B.C. Mondal, Shaheed Nk/RO Om Prakash, and Shaheed CT Yashpal Sharma—later succumbed to their injuries, attaining martyrdom in the line of duty.
