



# Kerala to study amoebic infection, prepare action plan: Health min


Health department has also decided to assess the condition of water bodies in the state

THE health department has decided to take up research on amoebic meningoencephalitis after the deadly infection has been reported in different districts in the state, said Health Minister Veena George. The department will study the rise in the number of cases of the disease in the state.

The research, according to the minister, will be the first such attempt made at the global level. She was speaking at a technical workshop organised by the department at the Government Medical College here on Tuesday.

The research will be based on the One Health approach in collaboration with expert organisations like ICMR and the Indian Institute of Science. Experts from ICMR, IAV, Pon-

tailed study report on the factors that favour the growth of amoeba. The department has also decided to assess the condition of water bodies in the state and an action plan will be formulated based on the one health approach.

Though considered rare and highly fatal, the state reported

19 cases which included 5 casualties. When there was a cluster in Thiruvananthapuram, the first case was detected and then other infected people were identified. Only 11 people have recovered from the disease in the world.

"The state has been able to improve the recovery rate. So far, 4 people have recovered from the disease in the state," said the minister. All the confirmed cases in Kerala have had contact in one way or the other with contaminated water where amoeba is likely to be present.

# Madras HC halts Nilgiris resorts demolition by 2 weeks, seeks clarification from TN govt

THE first bench of the Madras High Court has given two-week interim relief to 35 resorts in the Nilgiris facing demolition for being located inside the notified Sigur elephant corridor.

On August 16, executive officers of Sholur and Masinagudi town panchayats had issued demolition notices to resort

owners, directing them to raze the buildings within 15 days, failing which the government will demolish them and recover the costs from them. The demolition notices were issued based on the order from the Supreme Court-appointed three-member Sigur Plateau Elephant Inquiry Committee.

In response, a few resort owners filed a writ petition chal-

lenging the order and demolition notices, claiming that the inquiry committee went beyond its scope, from conducting inquiry into allegations of arbitrary variance in the acreage of the elephant corridor to declaring the property title of the resort owners as null and void under the Tamil Nadu Preservation of Private

Forest Act (TNPPF) 1949. When the matter came up for hearing, the first bench, comprising of Acting Chief Justice D Krishna Kumar and Justice P B Balaji, sought clarification from the Tamil Nadu government whether it can act upon the inquiry committee's report or should it be placed before the Supreme Court.

The HC also wondered whether it can admit the writ challenging the findings of an inquiry committee appointed by the Supreme Court.

Subsequently, the court adjourned the matter and asked the Additional Advocate General J Ravindran, representing the state, not to take any action for two weeks until clarification was provided. Senior Advocate

Salman Kurshid, appearing for the resort owners, had sought the interim protection.

AAG Ravindran told TNIE that the inquiry committee was empowered by the Supreme Court to pass final orders. "The chief secretary had convened a meeting, attended by all the officials concerned, and decided to proceed with the implementation of the inquiry com-

mittee's order," he said. Sources from the forest department told TNIE that after the chief secretary's meeting, a department order was issued to the Nilgiris collector to execute the demolition as ordered by the inquiry committee. The resort owners vehemently argued that the inquiry committee wrongfully declared their property titles void under the TNPPF Act.

# Yellow alert issued in northern districts

THE India Meteorological Department (IMD) has predicted that rainfall in the northern districts will intensify in the coming days.

A yellow alert has been issued in Kozhikode, Kannur, and Kasaragod for Wednesday, followed by an orange alert in Kozhikode and Kannur for Thursday.

The offshore trough now runs from south Gujarat to central Kerala coast.

According to the IMD, rain or thundershower is most likely to occur at most places in the state till September 2.

Thunderstorms with lightning are likely to occur at one or two places in the state till Wednesday. Fishermen are advised not to venture into the sea till August 31.

Bayar in Kasaragod received the maximum rainfall of 11 cm on Tuesday followed by Cheruvanchery (9 cm) in Kannur.
