E - AUCTION SALE NOTICE

Whereas **Borrower:** **Mrs.K.Latha**, W/o, M.Karthikeyan, **Co-Borrower:** **Mr.M.Karthikeyan**, S/o, Manivelan, **Guarantor:** **Mr.B.Vetrivelan**, S/o Balu, have borrowed money from Repco Home Finance Limited, **Perundurai Branch** against the mortgage of the immovable property more fully described in the schedule hereunder. Since the Borrower/s failed to repay the loan amount, the Company has issued a **Demand Notice** under Section 13(2) of the SARFAESI Act, 2002 on **07-03-2024** calling upon them to repay the amount mentioned in the notice being vide **Loan Account No.2101860001217** being **Rs.11,95,170/-** on **06-03-2024** together with further interest, costs and expenses within 60 days from the date of the said notice.

Whereas the Borrower & Co-Borrower, Guarantor having failed to pay the amount due to the Company as called for in the said demand notice, the Company has taken possession of the secured asset more fully described in the schedule hereunder by issuing **Possession Notice** under Section 13(4) of the Act on **27-07-2024**.

Whereas the borrowers having failed to pay the dues in full, the secured creditor, Repco Home Finance Limited has decided to sell the under mentioned secured asset in "**As is where is condition**" and "**As is what is condition**" under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules 2002 for realization of the debts dues to the company. The dues of the borrower being vide **Loan Account No.2101860001217** being **Rs.12,90,002/-** as on **11-09-2024**.

Description of the property

All the part and parcel of property situated at Erode Registration District, Chennimalai Sub-Registration District, Perundurai Taluk, Mugasipidariyur Village, Old S.F.Nos. 474, 475 & 476, New R.S.No.21, Punj. Hec. 1.49.5, sub-divided R.S.Nos. 21/2, 22/9, 22/10 & 22/11. The subject land bearing Site No.46, Southern portion, measuring 815½ sq.feet comprised in R.S.Nos. 21/2A, 22/9 & 22/10A is bounded as follows:

East of : 10 feet common Pathway
 West of : House Site No.45
 South of : House Site No.46, Northern portion
 North of : Others land

Admeasuring East – West on both sides 25 feet, North – South on the East 32 feet, North – South on the West 33.3 feet, totally 815½ sq.ft. or 750.76 sq.mtr. along with pathway rights through North – South and East – West layout Roads in Saravanam Puthur layout, to use Cart-track, passage and common right over Park and other common places mentioned in Gift Deed Doc.No.4439/2020 donated in favour of Mugasi Pidariyur Panchayat Board.

3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.
4. Offer without EMD and below the reserve price will be rejected.
5. The EMD amount shall be liable for forfeiture without any prior notice, if the successful bidder fails to adhere to the terms of sale.
6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interest bidding amongst themselves to enhance the offer price.

7. The successful bidder shall deposit 25% of the bid amount (inclusive of EMD) immediately after auction on the same day or not later than next working day of sale in cash or DD as above and the balance bid amount within 15 days from the date of confirmation of sale. In case of default, all amounts deposited till then shall be forfeited to the secured creditor and the property shall be resold without giving notice.
