DEMAND NOTICE

Under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (Act) read with Rule 3 of the Security Interest (Enforcement) Rules 2002.

CFM Asset Reconstruction Pvt. Ltd. (CFMARC) is a company incorporated under Companies Act, 2013 duly registered with Reserve Bank of India (RBI) as an Asset Reconstruction Company under section 3 of Securitisation and Reconstruction of Financial Assets and Security Interest Act, 2002 (SARFAESI Act). That M/s Ramsarp Industries Ltd. (hereinafter referred to as "Borrower") had availed various financial assistance from Punjab National Bank, State Bank of India, Karur Vysya Bank, Central Bank of India, Indian Overseas Bank, Industrial Development Bank of India, Canara Bank, Oriental Bank of Commerce, Development Credit Bank and Phoenix ARC Private Limited (to whom loan was assigned by Federal Bank Limited) (hereinafter referred to as the "Original Lender"). Borrower along with guarantors and the mortgagee had created the security interest on its movable and immovable properties to secure the repayment of loans. Details of various loan documents executed by the borrower, guarantor and mortgagee towards the credit facilities granted by the Original Lender.

Subsequent to the defaults made by the Borrower, the Original Lender had declared its account as Non-Performing Asset (NPA) on 28.01.2012 in accordance with Guidelines and Directions issued by Reserve Bank of India (RBI) from time to time. Thereafter, the Original Lender had pursuant to the various Assignment Agreements respectively assigned all its rights, title, interest, in the Loans along with Security Interests underlying thereto in favour of the Asset Reconstruction Company (India) Limited (ARCL) (hereinafter referred to as "Assignor"). Further, the Assignor has assigned the financial assets of the borrower along with underlying security interest and all rights title and interest therein to CFM Asset Reconstruction Pvt. Ltd. ("CFMARC") under the provisions of SARFAESI Act.

CFMARC has acquired the entire Financial Assets along with underlying security interest of the borrower under the provisions of section 5 of the SARFAESI Act from the Assignor. The Assignor has assigned all the rights, title and interests of Borrower in favour of CFMARC acting in its capacity as trustee of the CFMARC Trust-81 Ramsarp Industries Ltd. vide registered Assignment Agreement dated 23.04.2021. By virtue of assignment of Financial Assets as per financial documents and the underlying securities, CFMARC has stepped into the shoes of Secured creditor to the borrower and is entitled to recover outstanding dues and enforce its underlying security interest.

Subsequently, a resolution plan was approved by the competent authority pursuant to this approval, an amount of Rs. 38,22,47,762/- (Rupees Thirty Eight Crores Twenty Two Lakhs Forty Seven Thousand Seven Hundred Sixty Two Only) was successfully recovered from the debtor over the immovable properties in favour of IDBI as detailed in SCHEDULE-1.
