# Bangladesh has reached its limits: Yunus on Rohingyas

ANI NEW YORK

The Chief Advisor of the interim government in Bangladesh, Muhammad Yunus, stressed on the urgent need for the repatriation of Rohingyas during a high-level meeting at an event on the sidelines of the 79th United Nations General Assembly in New York on Tuesday.

Yunus highlighted the significant challenges that Bangladesh has been facing due to the presence of over 1.2 million displaced Rohingyas from Myanmar.

Yunus pointed out that while Bangladesh has shown empathy in hosting the Rohingyas, the costs associated with this situation – social, economic, and environmental – are considerable. He emphasised that Bangladesh has reached its limits, adding that repatriation remains the only

sustainable solution to the ongoing crisis.

"Despite hosting the Rohingyas with great empathy, a densely populated Bangladesh has been incurring so much in terms of social-economic-environmental costs. These culminate in a series of traditional

and non-traditional security risks for us. Much of our own development gains are at stake. Clearly, Bangladesh has reached its limits. Therefore, as much as Bangladesh engages in humanitarian aspects or ensuring justice, repatriation of the Rohingyas remains the

only sustainable solution to the protracted crisis," Yunus said. The Nobel laureate appealed to the international community to revisit its approach to the Rohingya crisis. He warned that the Rohingya crisis affected the whole region, not just Bangladesh,

He noted that several international resolutions have called for conditions conducive to the safe return of the Rohingyas. However, since the crisis began seven years ago, no Rohingya has been able to return to Myanmar, which has created uncertainty for the displaced community and their hosts, while humanitarian support continues to decline.

"Several UN General Assembly, Human Rights Council and even Security Council Resolutions on Myanmar have asked for creating a conducive environment for the dignified, safe and sustainable return of the Rohingyas. Regrettably, with the root causes of the crisis in Myanmar not addressed in the last seven years, not a single Rohingya could return to their homeland," Yunus said. "Creating an inclusive society in Myanmar is key where all ethnic communities can live in peace and harmony.

### BANGKOK King blesses same-sex marriage

Thailand's landmark marriage equality Bill was officially written into law on Tuesday, allowing same-sex couples to legally wed. The law was published in the Royal Gazette after endorsement by King Maha Vajiralongkorn, and will come into effect in 120 days. This means LGBT+ couples will be able to register their marriage in January next year, making Thailand the third place in Asia, after Taiwan and Nepal, to allow same-sex marriage.

### WASHINGTON Qatar in US visa waiver plan

Qatar has become the first Gulf country admitted into the US visa waiver programme, the United States has announced, in a move that will allow Qatari citizens to travel visa-free to the country for up to 90 days. In a joint statement on Tuesday, the US State Department and the Department of Homeland Security said Qatari citizens would be able to apply no later than December 1.

### USA Man executed for murder

A Missouri man, Marcellus Williams, 55, who was convicted of breaking into a woman's home and repeatedly stabbing her in 1998 was executed Tuesday over the objections of the victim's family and the prosecutor, who wanted the death sentence commuted to life in prison. Williams was convicted for killing of Lisha Gayle, who was stabbed during the burglary of her suburban St. Louis home.

### AUSTRALIA Teen charged with murder

An Australian teenager has been charged with the fatal stabbing of a 16-year-old in the Australian state of Victoria. Victoria Police said on Wednesday that they had charged a 15-year-old boy with one count of murder after a 16-year-old was killed in a stabbing at a shopping centre in Melbourne's outer western suburbs on Tuesday. Emergency services were called where the 16-year-old was found with life-threatening injuries. He died at the scene. The local 15-year-old would appear at a children's court at a later date.
