

# 5 held in connection with youth's murder

During Ganesha fest, relatives fought with each other, leading to the murder of one of them

KARWAR police on Tuesday arrested five people in connection with the murder of their relative over a trivial issue during Ganesha Chaturthi. The Ganesha festival is performed to ward off troubles, but trouble has started in the family on the festive occasion. It all started when cousins, who assembled to celebrate Ganesha festival, fought with each other and led to the murder of one of them, Sandesh Borkar.

The incident occurred on last Saturday afternoon when father of the victim Prabhakar Borkar, who had come with his

two sons Sharad Borkar and Sandesh Borkar to their ancestor's house in Karwar from Sirsi. The family was residing in Sirsi as they were working in a private firm there. After welcoming the god together, during the free time, Prabhakar Borkar, father of the victim, raised the issue of his contribution of Rs 8,000 made last year for Ganesha celebrations which was meant for this year.

One of their cousins Rathan Borkar replied bluntly, saying that he has already spent it for himself. An angry Sharad questioned this, there ensued an ar-

gument and fight between him and his cousins. Sharad was pushed by his cousins and was injured in the process. Seeing him hurt, his father Prabhakar and brother Sandesh interfered to protect him when Manish, the prime accused and son of their cousin Kiran Borkar, brought out a knife and allegedly stabbed Sandesh.

In his complaint to Karwar town police, Sharad said, "I questioned him (Rathan) why did he spend the money without informing other members of the family? it was supposed to be reserved for the festival. There ensued an

argument and Rathan slapped me and there was a fight and they pushed and I was injured in my shoulder. My father and my brother Sandesh interfered to protect me. At this moment, Manish, son of Kiran, brought a knife and plunged it into the heart of Sandesh. Sandesh collapsed there. I rushed him to the civil hospital where he died."

"I was injured badly in this process," he said in his complaint. Based on the complaint, town police under the guidance of SP B Narayan has arrested the accused. The accused have been produced before court and further investigation is on.



# Ganesha panel skips DJ party, uses money for road repair

SHOWING their social commitment over the religious event, a Ganesha festival committee in Koppal has cancelled DJ and other celebrations and used the money kept for it to repair the main road of the village.

The incident happened at Kinnal village of Koppal district. Kinnal villagers had installed a Ganesha idol and planned to organise the visarjan programme in a grand way.

After the installation, the committee had a rethink and decided to use the money for development of a road which has been in a bad condition for the past few years. Now, the road work has started. The main road which connects Kinnal to Koppal is a busy road where thousands of people daily visit Koppal. Kinnal is 18 km from Koppal town. The main road from Kinnal to Koppal town has been under repair for a few years. Villagers submitted a memorandum to the officials concerned and local leaders many times, but in vain. Students and workers, who used to travel on this road, suffered a lot during the rainy season. Many accidents have been reported on this road for the past few months

but no local leader or any staff from the department concerned came forward to repair the road.

Kinnal village's Kamana-katti Hindu Mahamandal Ganesha Committee members decided to use the money that they planned to spend for DJ and invest the same to repair the road. Some villagers have also joined their hands in the work and they brought earth movers and other equipment on rent and started the road work. Village youths also agreed to avoid using DJ this time and use the money for the road development as the road's everyone's requirement. Members of the Ganesha committee said, "Every year, we collect money from all villagers to or-

ganise Ganesha festival and every year, we bring a DJ where we all dance for hours and our village youths enjoy this programme. But this time we have planned to use the same funds for road repair. We have complained about the road to the officials concerned many times and they have promised to do the needful but the roads were still in pathetic condition. Hence, we all decided to repair the road and other villagers have also joined us and we started the work from Wednesday." An official from Koppal district administration said, "We have not got any information on Ganesha committee members repairing the road but we will soon check on the same."

He was speaking after attending a function at RDPR University in Gadag. "We are planning to meet the Prime Minister. If our fight will not succeed, we have to fight it le-

gally," said H K Patil. Answering a question on former CM Basavaraj Bommai's statement that the Congress is responsible for the Mahadayi issue, he said that the then prime minister Manmohan Singh formed a tribunal and the tribunal was made to save time. "But, the BJP showed a document that Goa had agreed and used the same during Lok Sabha elections, but nothing happened," he claimed.
