**Four tax officials punished for 'irregularities' in Kurnool**

Four officials of the Commercial Taxes department, who were posted at the Panchalingala check-post in Kurnool district, were punished for allegedly committing irregularities on Wednesday, after common disciplinary proceedings by the State government. In 2016, the Anti Corruption Bureau had conducted a surprise check at the check-post and found the DCTO D. Hussain Peera, ACTO B. Sreedhar, junior assistant M. Naga Pullaiah and office subordinate P. Satyanarayana allegedly committing irregularities. In 2018, the government initiated disciplinary proceedings appointing the Commissioner of Inquiry, who submitted a report and the charged officers were proven guilty. The government issued an order withholding one increment of Mr. Peera and Mr. Sreedhar with cumulative effect and withholding two increments of Mr. Pullaiah and Mr. Satyanarayana with cumulative effect.

**SPMVV's TBI selected for GENESIS scheme of MeitY**

SSIIE-TBI, the Technology Business Incubator (TBI) of Sri Padmavati Mahila Viswa Vidyalayam (SPMVV), has been selected as the 'implementing agency' for the GENESIS scheme of the Union Ministry of Electronics and Information Technology (MeitY). **Arrangements for free sand supply completed: Collector**

T.S. Chetan informs that individuals will now be required to apply online for free sand, in order to ensure transparency in the distribution process

Sri Sathya Sai District Collector T.S. Chetan announced that all arrangements for the State government's free sand supply programme at the Collectorate's mini-conference hall have been completed on Wednesday.

Mr. Chetan, along with Joint Collector Abhishek Kumar, and Additional SP Srinivasulu reviewed the online application process in the district. He emphasised the implementation of the new guidelines for the online application and distribution of free sand, as per the State government's directives. Individuals will

now be required to apply online for free sand, in order to ensure transparency and accountability in the distribution process, he informed.

Moreover, the registration of vehicles for transporting sand within the district was mandated to be completed by Wednes-

day evening to prevent the illegal transportation of sand. Mr. Chetan highlighted the provision of training for digital assistants in the village/ward secretariats, who will subsequently train staff members on the new system.

He stated that only vehicles equipped with GPS and registered with the Department of Mines will be permitted to transport sand. Stringent monitoring measures, including the presence of officials and specific vehicle loading regulations have been implemented. It was also specified that sand would be supplied from designated stockyards in Mudigubba and Tadimarri mandals.

**Two students killed in road mishap**

Two polytechnic students were killed in a collision between a tractor and a two-wheeler on the Cheruvukatta Road junction in Kuppam town on Wednesday. According to Kuppam Town CI G.T. Naidu, three students of Kuppam Polytechnic College, identified as Puneeth Kumar, Anand Babu, and Manjunath Reddy, were returning to Kuppam after seeking medical treatment at Kuppam Medical College.

A tractor travelling from Gudupalli toward Vijalapuram collided with the students' two-wheeler. Mr. Reddy of Tirupati and Mr. Babu of Madanapalle succumbed to injuries at the accident site, however, Mr. Kumar from Madanapalle survived with severe injuries and is being treated at Kuppam Medical College. The police registered a case and the bodies have been sent for autopsy.
