E - AUCTION SALE NOTICE

Whereas the Borrower & Co-Borrower, Guarantor having failed to pay the amount due to the Company as called for in the said demand notice, the Company has taken possession of the secured asset more fully described in the schedule hereunder by issuing **Possession Notice** under Section 13(4) of the Act on **28-08-2019**.

Whereas the borrowers having failed to pay the dues in full, the secured creditor, Repco Home Finance Limited has decided to sell the under mentioned secured asset in "**As is where is condition**" and "**As is what is condition**" under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules 2002 for realization of the debts dues to the company. The dues of the borrower being vide **Loan Account No.2161871580030** being **Rs.18,24,241/-** as on **16-09-2024**.

Description of the property

All that piece and parcel of Property situated at Ariyalur District, Ariyalur Registration District, No.1, Joint Sub Registrar, Ariyalur, Ariyalur Taluk, in Kattupringiyam Village, H/o Periya Nagalur Village, Old Natham Survey No.290 out of Hec 5.99.5 Ares, a site measuring 58' in East-West 38' in North-South on the West and 37' in North-South on the East admeasuring 2175 Sq.ft., lie as vacant site with a terraced building 416 Sq.ft., bearing D.No.4/954 with service connection No. 178, thereon situate with in the following four boundaries:

2. The intending bidders of the property should send their bids in the prescribed tender form in a closed cover along with EMD of 10% of the reserve price by means of RTGS / NEFT / DD / Banker's Cheque drawn in favour of "**Repco Home Finance Limited**" payable at **Perambalur Branch (Now Ariyalur Branch)** or on the website **www.bankauctions.in** Tender form not in the prescribed format will not be accepted.
3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.
4. Offer without EMD and below the reserve price will be rejected.
5. The EMD amount shall be liable for forfeiture without any prior notice, if the successful/ bidder fails to adhere to the terms of sale.
6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interest bidding amongst themselves to enhance the offer price.

The bidder shall bear the 1% income tax on the bid multiplier amount and the Bank shall not take any responsibility for the same.
