Whereas the **Borrower and Legal Heir I of Co-Borrower: Mr.Sourav Chakraborty**, S/o. Mr.Subhasish Chakraborty, **Co-Borrower (deceased): Mr.Subhasish Chakraborty**, S/o. Late. Kali Kumar Chakraborty and **Guarantor and Legal Heir II of Co-Borrower: Mrs.Sandhya Chakraborty**, W/o. Mr.Shubhasish Chakraborty, have borrowed money from Repco Home Finance Limited, **Durgapur** Branch against the mortgage of the immovable property more fully described in the schedule hereunder. Whereas the Borrower, Co-Borrowers & Guarantor having failed to pay the amount due to the Company as called for in the said demand notice, the Company has taken possession of the secured asset more fully described in the schedule hereunder by issuing **Possession Notice** under Section 13(4) of the Act on **28.04.2023**.

Whereas the Borrowers having failed to pay the dues in full, the secured creditor, Repco Home Finance Limited has decided to sell the under mentioned secured asset in "**As is where is condition**" and "**As is what is condition**" under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules 2002 for realization of the debts dues to the Company. The dues of the Borrower vide Loan Account No. **2061870000369** being **Rs.45,86,162/-** as on **11.09.2024**.

### Description of property

#### **Schedule A**

Burdwan (now Paschim Barddhaman), Jemua Gram Panchayat, land classified as bastu, B.L & L.R.O, Faridpur – Durgapur, including the multistoried buildings, ie, Block Nos. 4. Offer without EMD and below the reserve price will be rejected.
5. The EMD amount shall be liable for forfeiture without any prior notice, if the successful/ bidder fails to adhere to the terms of sale.
6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interse bidding amongst themselves to enhance the offer price.

15. In compliance with Section 194 IA of the Income Tax Act, 1961 income tax @ 1% on the Reserve Price shall be deducted and paid under the PAN Number of the Purchaser. The bidder shall bear the 1% income tax on the bid multiplier amount and the Bank shall not take any responsibility for the same. In case of any sale / transfer of immovable property

of Rupees Fifty Lakhs and above, the transferee has to pay an amount equal to 1% of the consideration as Income Tax.
