On 14 October 1966, a road opening party from 1 Battalion of CRPF was tasked with securing Nunshang Bridge in Ukhru, Manipur, for an incoming convoy from Imphal. Upon arrival, the party was ambushed by 300 insurgents armed with automatic weapons. Constable Devi Dutt, with remarkable composure, quickly took position, unleashing heavy fire from his LMG and rallying his comrades to hold their ground. He continually shifted positions to counter the attack until he was fatally hit. Five other personnel made the supreme sacrifice that day, and Constable Naresh Lal succumbed to his injuries on 17 October.

On 17th October 1991, based on intelligence inputs, 18 Battalion of CRPF launched an anti-terror operation in Kapurthala, Punjab. As the troops advanced through Benowal Main Bazar, a hidden terrorist opened indiscriminate fire from a narrow lane. The troops retaliated, but the terrorist fled, exploiting the crowd and tight lanes. In the exchange, Constable L. Shakthivel sustained grievous injuries and ultimately made the supreme sacrifice in the line of duty.


