

Sindhu, Lakshya eye comeback at Arctic Open after Paris setback

The tournament marks the first outing for the duo since the Olympic Games; they have reassessed their performances and implemented changes with the hope to regain their rhythm

Star shuttlers P.V. Sindhu and Lakshya Sen will lead the Indian contingent at the Arctic Open Super 500 tournament commencing here on Tuesday, as they look to reclaim their momentum on the international stage following a medal-less outing at the Paris Olympics.

This tournament marks the first outing for Sindhu and Lakshya since the Olympic Games, and they are keen to reset their goals.

The duo has reassessed their performances and implemented changes to regain their rhythm. Sindhu has roped in Anup Sridhar and Korean legend Lee Hyun Il as her new coaches, moving on from Indonesia's Agus Dwi Santoso.

Physical assessment
Lakshya, who narrowly missed a medal in Paris, spent time at the Red Bull Arena in Austria for physical assessment.

In the opening round, Sindhu, who exited in the round of 16 in Paris, will face familiar rival Canada's Michelle Li, while Sen, who lost in the bronze medal playoff, will compete against Denmark's Rasmus Gemke.

Double Olympic medalist Sindhu is favoured to overcome Li and could face 18-year-old Japanese sensation Tomako Miyazaki, the 2022 junior world champion, in the next round, an opponent against whom she lost at the Swiss Open earlier this year.

Chance for revenge
For Lakshya, it's a chance for revenge against Gemke, having lost to him at the India Open in 2023.

If he overcomes Gemke, he might face seventh-seeded Chou Tien Chen of Chinese Taipei.

K. Srikanth, returning to action at the Macau Open after a four-month injury layoff, will compete in the qualifiers alongside younger compatriots Kiran George and Sathish Kumar Karunakaran.

Former World No. 1 Srikanth is set to face George, while Sathish will battle against France's Arnaud Merkle.

In women's singles, besides Sindhu, in-form Malvika Bansod and Aakarshi Kashyap are also in contention.

Malvika, who reached the quarterfinals at the China Open Super 1000, will

open against World No. 24 Sung Shuo Yun of Chinese Taipei, while Aakarshi will be up against Yvonne Li of Germany in the first round.

Promising player
Another promising player, Unnati Hooda, who won the 2022 Odisha Masters, will take on Heli Neiman of Israel in the qualifiers.

While there is no Indian representation in men's doubles, Rituparna Panda and Swetaparna Panda will compete in women's doubles, and Sathish will partner with Aadya Variyath in mixed doubles.

Junior Indian sailors strike it rich

Shreya Krishna of Tamil Nadu and Lahiri Komaravally of Hyderabad won gold and silver in the under 15 sub-junior event. Madhya Pradesh's Shashank Bhatam and Somya Singh claimed a silver each, while Statesmates Akshat Dohare and Shagun Jha took a bronze each in the boys' and girls' junior championships respectively. Telangana's Manya Reddy won silver in the women's class.

Ruthless Gauff beats Muchova in straight sets to win China Open

Coco Gauff overpowered Karolina Muchova in straight sets to win the China Open on Sunday for her second title of the year and eighth overall.

The 20-year-old American and last year's US Open champion stormed to victory 6-1, 6-3 in one hour, 16 minutes in Beijing.

After a disappointing few months by her standards, including surrendering her New York crown in the last 16, Gauff adds the China Open to her triumph in Auckland in January.

The sixth-ranked Gauff was under a new coaching team in the Chinese capital after splitting with Brad

Gilbert last month. "Today was by far my best match in a while," said Gauff, whose mother was court-side to see her biggest win since the US Open. She said keeping relaxed was key.

"I think I'm realising more and more each day

that tennis is not a measure of my value as a person," she said.

"I think the more you realise that, the more relaxed these tournaments become."

It was Gauff's third straight-sets win in as many matches against Muchova, who suffered a career-threatening wrist injury and missed 10 months of tennis before returning this summer.

It proved one match too far for Muchova, who at 49 in the world was the lowest-ranked finalist in the history of the prestigious WTA 1000 tournament.

"You kicked my butt," the Czech player, last year's French Open finalist and a two-time US Open semifinalist, told Gauff.

Muchova - who beat top seed Aryna Sabalenka in the last eight - called it her "weakest performance" of the tournament.

"Coco outplayed me today and I helped her a little bit. She pushed me and made me do those errors, but I did not help myself with my serve, which is my game usually."
