

Sat images show damage to military bases

Tehran's onetime nuclear weapons programme site, ballistic missile programme possibly hit in Israeli strikes

DUBAI

AN Israeli attack on Iran damaged facilities at a secretive military base southeast of the Iranian capital that experts in the past have linked to Tehran's onetime nuclear weapons programme and at another base tied to its ballistic missile programme, satellite photos analysed on Sunday.

Some of the buildings damaged sat in Iran's Parchin military base, where the International Atomic Energy Agency suspects Iran in the past conducted tests of high explosives that could trigger a nuclear weapon. Iran long has insisted its nuclear program is peaceful, though the IAEA, Western intelligence agencies and others say Tehran had an active weapons program up until 2003.

The other damage could be seen at the nearby Khojir military base, which analysts believe hides an underground tunnel system and missile production sites. Iran's military has not acknowledged damage at either Khojir or Parchin from Israel's attack early Saturday, though it has said the assault killed four Iranian soldiers working in the country's air defense systems. Iran announced Sunday a civilian also had been killed, but provided no details.


Iran's mission to the United Nations did not immediately respond to a request for comment. The Israeli military declined to comment.

Even after killing the top Hamas leaders, Israeli Defence Minister Yoav Gallant warned that "painful concessions" would be needed to secure the release of hostages held in Gaza and that military action alone will not achieve the country's war aims.

"Not all objectives can be achieved through military operations alone... to realise our moral duty to bring our hostages home, we will have to make painful concessions," Gallant said, in a speech marking the Hebrew calendar anniversary of the Hamas attack on October 7 last year.

Israel bombed Hezbollah and Hamas targets in Lebanon and Gaza on Sunday, with no respite in the conflict one day after its strikes on Iran raised fears of a broader war.

The Israeli military said it had killed 70 Hezbollah fighters and struck 120 targets in southern Lebanon and carried out "precision strikes" on weapons factories and storage facilities in the Iran-backed group's southern Beirut stronghold over the past day. In Gaza, it said, it had eliminated "40 terrorists over the past day". AP

Nuanced Khamenei response to Israeli attacks

TEHRAN

IRAN's supreme leader Ayatollah Ali Khamenei on Sunday said Israel's attack on the Islamic republic "should neither be exaggerated nor minimised". "The evil perpetrated by the Zionist regime (Israel) two nights ago must not be exaggerated or minimised," he said in a post on X, describing the deadly attack as a "miscalculation".

On Saturday, Israel carried out air strikes against military sites in Iran in response to Tehran's missile attack on October 1, itself a retaliation for the killing of Iran-backed militant leaders and a Revolutionary Guards commander.

At least four Iranian soldiers were killed in the attack which Iran said caused "limited damage" to a few radar systems.

The Israeli military has warned Tehran against responding. Iranian officials and media have since downplayed the Israeli strikes, highlighting Iran's defensive capabilities but issued no vows of a direct response. In his post, Khamenei said Israel "should understand the strength, will, and initiative of the Iranian nation and youth."

President Masoud Pezeshkian praised the fallen soldiers for their commitment to "defend their land without fear", while Foreign Minister Abbas Araghchi commended Iranians' "determination to defend" themselves.

"Senior Iranian officials simply do not want to increase tensions," said Fayyaz Zahed, international relations professor at the University of Tehran.

Egypt proposes 2-day ceasefire for 4 hostages

Egypt's president said his country has proposed a two-day ceasefire between Israel and Hamas during which four hostages held in Gaza would be freed. President Abdel-Fattah el-Sisi, speaking in Cairo, said the proposal also includes the release of some Palestinian prisoners and the delivery of humanitarian aid to Gaza Strip. There has been no immediate response from Israel or Hamas. El-Sisi said the proposal aims to "move the situation forward." He said that once the two-day ceasefire goes into effect, negotiations will continue to make it permanent. Mossad chief was travelling to Doha on Sunday for talks. AP

B'desh War Crimes Tribunal summons former army chief

DHAKA

BANGLADESH's International Crimes Tribunal (ICT) on Sunday summoned 20 individuals, including ex-army chief Ziaul Ahsan, 10 former ministers and two advisers to deposed prime minister Sheikh Hasina, to appear before it next month in connection with alleged crimes against humanity and genocide during the July-August uprising in the country.

According to the Bangladesh interim government, at least 753 people were killed and thousands injured during the uprising, which ICT prosecution team and the interim government termed crimes against humanity and genocide. Over 60 complaints of crimes against humanity and genocide have been filed against Hasina and her party leaders with the ICT investigation agency and the prosecution team so far.

The ICT directed authorities concerned to produce 20 people, including 10 former ministers and two advisers to former prime minister Hasina, before it on November 18, *The Daily Star* newspaper reported.

The order was issued by a three-member ICT bench led by its Chairman Justice Md Golam Mortuza Majumder, following an application from Chief Prosecutor Md Tajul Islam. On October 17, the tribunal is-

sued arrest warrants against Hasina and 45 others, including her son Sajeeb Wazed Joy and several of her former cabinet members. The ICT was formed by the Hasina-led Awami League government in March 2010 to try the perpetrators of the crimes against humanity committed during the 1971 war. It later formed ICT-2, and Jamaat and leaders of BNP party were executed following the judgments of the two tribunals. The tribunal remained dormant since mid-June after its chairman retired.

The interim government led by Chief Adviser Muhammad Yunus reconstituted the tribunal on October 12.

Nobel laureate Yunus, 84, became interim government's Chief Adviser.
