

SC to hear Madhu Koda's plea for stay on conviction today

NEW DELHI: The Supreme Court will hear on Friday a plea moved by former Jharkhand chief minister Madhu Koda, seeking a stay on his conviction in a coal scam case, to enable him to contest the upcoming state Assembly polls.

Thursday said the judges were not able to go through the case files as those were sent to them late and therefore, the matter will be taken up on Friday. The bench asked senior advocate R S Cheema, who appeared in the matter on behalf of the Central Bureau of Investigation (CBI), to go through an earlier judgment of the court that says for the suspension of a sentence, the threshold is different from what is there in bail cases.
