Russia's First Dy PM to visit India, focus on economic cooperation

DAYS AFTER the election of Donald Trump as the US President, Russia's First Deputy Prime Minister Denis Manturov is set to visit India on November 11-12 to hold key discussions on bilateral and global issues with the Indian leadership.

The Russian Embassy in New Delhi announced Manturov's visit Sunday. On November 11, Manturov will participate in the plenary session of the Russian-Indian Business Forum in Mumbai where the focus will be on expanding economic and business cooperation between the two nations. The forum, organised by Business Council for Cooperation with India and FICCI, will address issues such as industrial collaboration,

transport and logistics, finance, digital technologies and enhancing inter-regional cooperation. On November 12, Manturov will hold a bilateral meeting with External Affairs Minister S Jaishankar in New Delhi.

He will also participate in the 25th Session of the Intergovernmental Russian-Indian Commission on Trade, Economic, Scientific, Technical and Cultural Cooperation. The session will address the progress of ongoing bilateral initiatives and explore new areas for

collaboration. Manturov is also expected to hold a series of bilateral meetings with key Indian leaders to further discuss strategic cooperation, the embassy added. Russian President Vladimir Putin on Thursday congratulated Donald Trump on his victory in his first public comment on the US elections. The Kremlin earlier welcomed Trump's claim that he could negotiate an end to the conflict in Ukraine "in 24 hours" but emphasised that it will wait for concrete policy steps.

BJP video on social media spreading false charges against Opp: Cong to EC

THE CONGRESS submitted a complaint to the Election Commission on Sunday alleging that a BJP official had published a video on social media "in blatant violation of the Model Code of Conduct" and other election laws.

Jharkhand Assembly election will be held in two phases on November 13 and 20. Congress MP and the party's communication in-charge Jai Ram Ramesh wrote to the poll panel stating that "false allegations and statements are being ascribed to leaders of the

JMM, Congress and the RJD" through the advertisement published by the Jharkhand BJP page on November 9. "Additionally, the leaders are being portrayed in a negative and false light, with the sole intent of propagating false and baseless narratives against them," the letter read and requested the poll panel to issue directions for the "immediate takedown of all videos" and sought action against the BJP. The "BJP had first tried to use actors who resemble the leaders of JMM, INC and RJD," the letter alleged, adding that "consequently, the advertisement has tried to raise several blatantly false allegations against the leaders of the
