

Cong 'shahi parivar' hell-bent on breaking OBC-ST-SC unity: PM

PRIME MINISTER Narendra Modi Sunday attacked the Congress, accusing that its 'shahi parivar' (royal family) is hell-bent on breaking the ST-SC-OBC unity to "snatch reservations under an evil design".

At Gumla, he accused the JMM-led coalition of looting the state's rich resources such as minerals, forest, sand and coal, putting 'Roti-Beti-Mati' (bread, land and daughter) at grave threat. He also accused the ruling dispensation of facilitating illegal immigration.

"The Congress knows that if STs, SCs and OBCs are united, they will pose a threat to the

party's existence. This is the reason the Congress 'shahi parivar' is hell-bent on break their unity... They want to snatch reservations.

"The Congress is trying to pit one tribal community against another... Munda against Oraon, Lohra against Kharia, Kharwar against Korwa etc. with an agenda to break the tribal society's strength," he said.

Video shot at cafe used to lackmail, rape college student in Odisha, 6 held

THE CUTTACK police in Odisha have arrested six people, including a minor, for allegedly raping a college student several times by blackmailing her with her obscene videos, said police sources. One of the arrested accused is the college student's boyfriend, the police said.

Cuttack Deputy Commissioner of Police (DCP) Jagmohan Meena said a complaint was reported in one of Cuttack's police stations on November 4, following which a case was registered under different sections for sexual assault, intimidation, abetment and under the Scheduled Caste and Scheduled Tribe (Prevention of Atrocities) Act, and the Information Technology Act against the six accused.

"According to the FIR, the accused had got some obscene videos of the victim, and they started blackmailing her by showing the videos. Two different people allegedly sexually assaulted the victim on two different dates. Two more people were involved in intimidation and abetment," said Meena on Friday.

The police arrested the six accused on two different dates and seized their mobile phones which will be sent to the State Forensic Science Laboratory (SFSL) for further investigation and to ensure that the videos are not spread further, Meena said.

Police sources said that according to the complaint, the victim had gone to a cafe in Cuttack with her boyfriend to celebrate her birthday during the Dussehra festival. The cafe owner allegedly captured some of their intimate moments on his mobile phone. The accused blackmailed the victim by showing her those intimate videos and raped her several times. After the woman complained, the police formed a special team to probe into the matter and immediately arrested the accused, said a police officer.

Chhattisgarh: 2 kids killed in attack by wild tuskers

Surajpur: Two children were trampled to death by a herd of wild elephants in Chhattisgarh's Surajpur district, a forest official said on Sunday.

The incident occurred Saturday night on Tongtaiyya hill near Maheshpur village under Ramanujanagar forest range, the official said.

He said the victims, Dishu (11) and his sister Kajal (5), belonged to the Pando tribe, a particularly vulnerable tribal group, he said. As per preliminary information, a herd of 11 elephants attacked a hut on the hill. While the parents managed to escape, the tuskers trampled the children to death, he said. Forest and police personnel reached the spot and sent bodies for post-mortem. PTI

On 11th November 2013, troops from 186 Battalion of CRPF were deployed to secure polling booths near PS-Katekalyan, district Dantewada, on the day of Assembly Elections. As they neared a polling booth in Naynar village, Maoists lying in ambush launched a fierce attack. Exposed in open terrain, the troops came under heavy fire. Amid the assault, Shaheed HC V C Joseph courageously moved to the frontline, launching a counterattack that injured several Maoists, forcing them to retreat. In this heroic act, he sustained injuries and ultimately sacrificed his life. For his valour, he was posthumously awarded the Police Medal for Gallantry.

On 11th November 2002, a CRPF convoy traveling from Srinagar to Jammu encountered a devastating IED blast near village Ramu, PS Banihal, District Doda. Militants in ambush detonated the explosive, hitting one of the buses directly and causing severe injuries to its occupants. Despite an immediate search operation, the militants escaped, using the dense terrain to their advantage. Tragically, eight brave personnel—Shaheed SI Md. Ishaq Khan, Shaheed HC Manohar Mandal, Shaheed HC S. Ingte, Shaheed Constable Thirumallaiah, Shaheed Constable Raj Mohd., Shaheed Ct/Dvr Pradeep Singh, Shaheed Constable Tuntun Kumar, and Shaheed Constable Balbir Singh—succumbed to their injuries. Shaheed C. G.D. Bhai also attained martyrdom on 17th November due to his injuries.
