A trio of lions leaves the forest and roams the societies of Junagadh, locals worry for the lives of their children



Junagadh, In Junagadh, the number of lions roaming in the societies of Madhuram area has increased for a long time. Lions are making their home in the societies late at night or early in the morning. Due to which an atmosphere of fear has spread among the locals. Then on Monday morning, a video of a trio of lions killing a cow went viral on social media, due to which the forest department has taken up an investigation.

Cow killed in society square Videos of lions roaming around in the Girnar area of Junagadh, sometimes in the revenue area and sometimes in the residential area, have repeatedly gone viral on social media. Now, the lions have come not only in the revenue area but also in the residential area, killing the locals of the society. Just a few days ago, three lions had come to the Radhika Residential area. In which the lions went to hunt a cow in the parking lot of an apartment and the three lions fled after facing it. So, early on Monday morning, three lions killed a cow in the society square and enjoyed a feast of hunting. Then, the locals of this area have demanded that the forest department should take action to relocate these lions as soon as possible. Children are very worried: Ajay Varvi, a resident of the local society, said that early this morning, three lions killed a cow in our society. People from villages come to the city to live for their needs and for their children's studies. When the number of lions is increasing in the society, the forest department should immediately pay attention to this matter. Children are also very worried when the young children of the family living in the society are going to school or coming from tuition. Then the number of lions has increased in the society for the last one week. Then the forest department should take appropriate action in this matter as soon as possible. Forest Department has visited this society: Forest Department officer Arvind Bhalia on this matter, he said that these lions are from Girnar forest area and often go to the revenue area. But for the last long time this lion trio has been roaming around the society. When the video that has gone viral on social media was visited by the Forest Department, this society
