# IRRIGATION PROJECT: GOVT TO FORM TECH PANEL TO STUDY FARMERS' PROBLEMS

THE state government would constitute a 'technical committee' to study problems of the victims whose lands were acquired long back for constructing Karanja Irrigation Project in Bidar district, announced Chief Minister Siddaramaiah in Belagavi on Thursday. Speaking at a meeting held with representatives of the victims in the presence of Bidar District Minister Eshwar Khandre, Minister for Municipal Administration Rahim Khan and MLAs at Suvarna Soudha, Siddaramaiah said that to solve the problem of farmers whose lands were acquired for Karanja Irrigation Project of Bidar, the government would constitute a technical committee and to implement its report would be a good solution.

Bidar District Minister Eshwar Khandre, who briefed about the problem in the meeting, said that the land was acquired in the 1970s for the construction of the Karanja reservoir to provide irrigation facilities to 29,227 hectares of land in Bidar district, and the victims who have lost their land have not received appropriate compensation even today.

"Some people who lost their land have filed a case in court, and the court has ordered a compensation of Rs 88,000 per acre in one case. Therefore, the affected farmers are requesting for a one-time special package (compensation) from the government. When late Dharma Singh was the chief minister, a high-powered committee was formed in 2005. The committee headed by the Additional Chief Secretary had submitted its report in 2012 and recommended a special package for the rehabilitation of the victims. However, the cabinet rejected this recommendation," he explained.

Eshwar Khandre requested the chief minister for a one-time special package (ex gratia) to the Karanja aggrieved farmers on humanitarian grounds. MLAs Shaileendra Beldale and Prabhu Chavan, former minister Rajashakar Patil and others also appealed to solve the problem of the farmers who have given their lands for Karanja project on humanitarian basis. The chief minister responded to the request and decided to constitute a technical committee, a press note issued in this regard stated. KKRBD president Dr Ajay Singh, president of Kalyana Karnataka Horata Samithi Lakshman Dasti and president of Karanja Mulugade Raita Horata Samithi Chandrashekar Patil were present in the meeting.

## Ministers discuss relocation of Buddinni villagers at Suvarna Soudha

A MEETING was held to discuss problems of workers and villagers of Buddinni Mines of Hutti Gold Mines Company Limited at Suvarna Soudha in Belagavi on Wednesday.

Mines and Geology Minister S S Mallikarjun chaired the meeting in the presence of Raichur District Minister Dr Sharan Prakash Patil, Minor Irrigation, Science and Technology Minister N S Boseraju, Hutti Gold Mines Company Limited chairman G T Patil, and Manvi MLA Hampayya Nayak. In the meeting, the villagers of Buddinni said that the blasting operations of a gold mine at Buddinni village is causing a lot of trouble. "The village has to be relocated. Along with the com-

ensation, one member of each household should be given a job in the gold mine," they demanded. The ministers assured that Buddinni, which is close to the Hutti gold mines and is facing serious problems due to mining, will be relocated and the villagers will be given a job at the Hutti Gold Mines.

Officials informed that according to the Companies Act, there is a possibility of providing employment to landowners who have lost their land to mining.

There is no possibility of providing employment to the villagers who are being relocated. Minister N S Boseraju said if necessary, approval is obtained at the Hutti Gold Mines Company's board meeting, the nec-

essary amendments can be made at the government level. "Villagers of Buddinni have been suffering from this problem for several years. The hous-

es of these villagers have already been damaged due to mining, and it is necessary to relocate the houses from there. The villagers who lost their

houses should be provided with employment along with compensation," he added.

Mines and Geology Minister S S Mallikarjun responded positively to this and instructed the chairman of Hutti Gold Mines Company Ltd and officials to give priority to hiring these villagers primarily on a contract basis.

The officials were instructed to organise a meeting in Raichur with the chairman of Hutti Gold Mines Co Ltd, Raichur District Minister Dr Sharan Prakash Patil, Minister N S Boseraju, MLA Hampayya Nayak and the district administration to relocate the Buddinni villagers. It was decided to discuss the issue with the villagers and take a final decision in this regard.
