NIA conducts searches in BJP leader murder case

The National Investigation Agency (NIA) on Thursday conducted searches at multiple locations in Karnataka and Tamil Nadu in connection with the Praveen Nettaru murder case and recovered incriminating documents belonging to the suspects. As many as 19 people have been arrested in this case while four are absconding. Praveen Nettaru, BJP Yuva Morcha's Dakshina Kannada district secretary, was hacked to death on July 26, 2022, at Bellare village in Dakshina Kannada district (in the picture) by members of the banned Popular Front of India.

Boy critical after stampede at Pushpa 2 premiere

An eight-year-old boy is in critical condition after collapsing during a stampede at the premiere screening of the Allu Arjun-starrer Pushpa 2 at Sandhya Theatre in Hyderabad. The incident occurred late on Wednesday. The child was rushed to KIMS in a semi-conscious state, the hospital confirmed in a statement. His 35-year-old mother passed away due to severe injuries sustained during the stampede.

HC issues notice to Governor on Siddaramaiah's appeal

The High Court of Karnataka on Thursday ordered issue of notice to the Governor and others on an appeal filed by Chief Minister Siddaramaiah, who has challenged a September 24 judgment upholding permission granted by the Governor for conducting an investigation against him in connection with the illegal allotment of 14 sites to his wife by the Mysuru Urban Development Authority (MUDA).

SC quashes defamation case against Minister Murugan

Case was filed by the Murasoli Trust against the Minister for his comments during a press meet in 2020; trust accepts his statement that his remarks were not meant to cause injury to its reputation

The Supreme Court on Thursday quashed and set aside criminal defamation proceedings instituted by the Murasoli Trust against the Union Minister of State for Information and Broadcasting L. Murugan for his comments during a press meet in December 2020.

A Bench of Justices B.R. Gavai and K.V. Viswanathan closed the case after the Trust, represented by senior advocates N.R. Elango and Siddharth Luthra, "graciously" accepted Mr. Murugan's statement that he had no intention to cause injury or harm to the reputation of the Trust, which ran a highly reputa-

ble and prominent newspaper affiliated to the ruling Dravida Munnetra Kazhagam (DMK) in Tamil Nadu. Senior advocate K. Parameshwar, appearing for the Minister and BJP leader, said his client had no intention whatsoever to defame the Trust. The court recorded Mr.

Parameshwar's submission that his client had made the statements as a leader of a political party. Justice Gavai, when the case came up on Wednesday and before adjourning it to December 5, had addressed the Trust light-heartedly that "when you enter politics, you should be ready to receive all sorts of unwarranted, unnecessary compliments... In free speech issues, you need to give breathing space".

The court had said that to survive in politics, one needed to be thick-skinned against barbs. "Parties should fight their battles before the public," it had remarked. The defamation complaint against Mr. Murugan was filed by the Trust in a

Chennai court. The Madras High Court had refused to quash the defamation complaint in September 2023, following which Mr. Murugan had to move the top court.

The top court had initially stayed the defamation proceedings before the special court in Chennai. The defamation case against Mr. Murugan was that he made remarks in a press meet to create an impression that the trust was functioning in a panchami land (Depressed Class land) without any right or title. The trust had argued that the remarks were made "intentionally causing loss of reputation to the Murasoli Trust in the mind of the general public".

Telangana Police detain BRS leaders

Mr. Rao was detained after he attempted to meet Mr. Reddy, who was booked by the police for obstruction of police duty, criminal intimidation, wrongful restraint and oth-


er charges on Wednesday. Mr. Rao arrived at Mr. Reddy's residence on Thursday but was blocked by the police. This led to a heated exchange between Mr. Rao and the police, cul-

minating in his detention. After Mr. Rao, former Minister and Suryapet MLA G. Jagadish Reddy was also detained by the police. The sequence of events

leading to a case against Mr. Kaushik Reddy began on Wednesday after he reached Banjara Hills police station to file a complaint against Telangana Chief Minister A. Revanth Reddy, alleging illegal phone tapping. A confrontation ensued between Mr. Kaushik Reddy and the Station House Officer, who reportedly attempted to leave without registering the complaint. Following the altercation, the police filed a case against Mr. Kaushik Reddy.
