Whereas the **Borrower: Mrs.S.Theja Rani**, W/o, Mr.Mohankumar, **Co-Borrower-I: Mr.V.Mohankumar**, S/o, Mr.Vasudeva Naidu, **Co-Borrower-II: Mr.M.Manoj**, S/o, Mr.V.Mohankumar, have borrowed money from Repco Home Finance Limited, **Anna Nagar Branch**, against the mortgage of the immovable property more fully described in the schedule hereunder. Whereas the Borrower & Co-Borrower, Guarantor having failed to pay the amount due to the Company as called for in the said demand notice, the Company has taken possession of the secured asset more fully described in the schedule hereunder by issuing **Possession Notice** under Section 13(4) of the Act on **20.12.2023**.

Whereas the Borrowers having failed to pay the dues in full, the secured creditor, Repco Home Finance Limited has decided to sell the under mentioned secured asset in "**As is where is condition**" and "**As is what is condition**" under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules 2002 for realization of the debts dues to the Company. The dues of the Borrower vide **Loan Account No.1171813004288** being **Rs.98,04,040/-** as on **26.12.2024**.

The bidder shall bear the 1% income tax on the bid multiplier amount and the Bank shall not take any responsibility for the same.
