E - AUCTION SALE NOTICE

Whereas the Borrower & Co-Borrowers having failed to pay the amount due to the Company as called for in the said demand notice, the Company has taken possession of the secured asset more fully described in the schedule hereunder by issuing **Possession Notice** under Section 13(4) of the Act on **14.10.2024.**

Whereas the Borrowers having failed to pay the dues in full, the secured creditor, Repco Home Finance Limited has decided to sell the under mentioned secured asset in "**As is where is condition**" and "**As is what is condition**" under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules 2002 for realization of the debts dues to the Company. Description of property

All the piece and parcel of land together with building situated at Coimbatore Registration District, Kinathukadavu Sub-Registration District, Madukkarai Taluk (formerly known as Coimbatore South Taluk), Chettipalayam Village, comprised in Survey No.150/1, Punj. Acre 8.76 or Punj. Hec. 3.45.5, Survey No.151, Punj. Acre 6.26 or Punj. Hec. 2.53.5, Survey No.152, Punj. Acre 7.11 or Punj. Hec. 2.88.0, Survey No.153/1, Punj. Acre 2.85 or Punj. Hec. 1.15.5 and Survey No.154/1, Punj. Acre 1.77 or Punj. Hec. 0.71.5, totally Punj. Acre 26.75 or Punj. 3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.
4. Offer without EMD and below the reserve price will be rejected.
5. The EMD amount shall be liable for forfeiture without any prior notice, if the successful/ bidder fails to adhere to the terms of sale.
6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interse bidding amongst themselves to enhance the offer price.
7. The successful bidder shall deposit 25% of the bid amount (inclusive of EMD) immediately after auction on the same day or not later than next working day of sale in cash or DD as above and the balance bid amount within 15 days from the date of confirmation of sale. In case of default, all amounts deposited till then shall be forfeited to the secured creditor and the property shall be resold without giving notice.
