Late NkMuraledharan G was serving with 8 Mtn Div Int & FS Coy deployed at Sopore, Dist-Baramulla, J & K and engaged in active Counter Insurgency Operation. On 30 Nov 1996, while carrying out his duties, he fell victim to an attack by unidentified militants. Despite efforts to save him, he succumbed to his injuries and was died on the spot. On this auspicious day Intelligence Corps salute and pay homage to this brave soldier who made the supreme sacrifice in the finest traditions of the Indian Army.

On 3rd December 2014, troops of 183 Battalion of CRPF were deployed for road sanitization to ensure the safe induction of CISF personnel during Assembly Elections. Pickets were established at regular intervals, including one near village Pahoo, Pulwama. At around 1715 hrs, shortly after a CISF convoy passed, unidentified militants, exploiting the crowded surroundings, hurled a grenade at the picket and fled in a vehicle. In the attack, ASI Samsher Singh sustained critical injuries and made the supreme sacrifice in the line of duty.

On 3rd December 2004, two militants, under the cover of darkness, launched a heavy attack with gunfire and grenades on the sentry post of 16 Battalion, CRPF in Sopore, Baramulla. Despite a brave response, the sentry was martyred. The militants then stormed the camp, firing indiscriminately and targeting the barracks. CRPF troops retaliated, forcing them to take cover inside a room. An assault team was quickly formed, and after a swift room intervention drill, both militants were neutralized. In this fierce gunfight, five brave CRPF troopers- HC A. Thulasi, Constable Gagan Singh, Constable Rampal Sharma, Constable K. Shiv Raj, and Constable Barber Mohd. Sayeed—made the supreme sacrifice in the line of duty.
