

FIVE-DAY MALIKAPPURAM PROCESSION TO END TODAY

THE FIVE-DAY Malikappuram procession, carrying the 'thidambu' of Malikappuram Devi, will conclude on January 18. The procession, leaving Malikappuram temple after deapradhana, padi pooja and athazha pooja, will go to Saramkuthi instead of up to the front of Holy Steps, and return to Malikappuram after confirming the presence of the pilgrims who come for the first time to the hill shrine.

Neyyabhishekam offering by devotees will conclude on Saturday, marking the conclusion of the important offering during the ongoing pilgrimage season.

Kalabhabhishekam will be the important special ritual to be performed on Saturday. As part of the ritual, the thantri will perform brahmakalasa

pooja at the mandapam of the temple in the presence of melsanthi Arunkumar Nampoothiri at 9 am.

The ritual will conclude with kalabhabhishekam on the idol during uchcha pooja after the procession carrying the brahmakalasa led by the thantri circumambulating the

sreekoovil. 'Guruthi' ritual, one of the concluding rituals of the temple during the pilgrimage season, will be held at Malikappuram on Sunday. The ritual, performed for the sub-gods of Lord Ayyappa, will be held after the closure of Lord Ayyappa and Malikappuram temples at 10 pm. The hill shrine will be closed at 6 am after the customary darshan by the representative of Pandalam Valiyaraja. After the darshan, the sreekoovil will be closed after Harivarasanam. The Thiruvabharanam return procession will leave Sammidhanam at 6:30 am for Pandalam Valiyakoickal Sree Dharma Sastha temple. The procession will reach Pandalam at 8 am on January 23 after night halts at Laha Forest Sathram, Perunad Kakkad Koyickal Sree Sastha temple and Aranmula palace near Lord Parthasarathy temple.
