**E - AUCTION SALE NOTICE**

Sale of Immovable Properties Mortgaged to Repco Home Finance Ltd.

Whereas the **Borrower: Mr.Pravin Mule**, S/o. Mr.Arun P Mule, **Co-Borrower: Mrs.Mule Rupali Pravin**, W/o Mr.Mule Pravin, and **Guarantor : Mr. Rajendra Suresh Kasar** have borrowed money from Repco Home Finance Limited, **Pimpri Branch** against the mortgage of the immovable property more fully described in the schedule hereunder. 5. The EMD amount shall be liable for forfeiture without any prior notice, if the successful/ bidder fails to adhere to the terms of sale.


6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interest bidding amongst themselves to enhance the offer price.
