# US proposes new curbs for export of AI chips

Tech firms slam move; Trump will have the final say as rules kick in only after 120 days

## WASHINGTON

THE Biden administration is proposing a new framework for the exporting of the advanced computer chips used to develop artificial intelligence, an attempt to balance national security concerns about the technology with the economic interests of producers and other countries.

But the framework proposed on Monday also raised concerns of chip industry executives who say the rules would limit access to existing chips used for video games and restrict in 120 countries the chips used for data centers and AI products. Mexico, Portugal, Israel and Switzerland are among the nations that could have limited access.

Commerce Secretary Gina Raimondo said on a call with reporters previewing the framework that it's "critical" to preserve America's leadership in AI and the development of AI-related computer chips.

The fast-evolving AI technology enables computers to produce novels, make scientific research breakthroughs, automate driving and foster a range of other transformations that could reshape economies

and warfare. "As AI becomes more powerful, the risks to our national security become even more intense," Raimondo said.

The framework "is designed to safeguard the most advanced AI technology and ensure that it stays out of the hands of our foreign adversaries but also enabling the broad diffusion and sharing of the benefits with partner countries."

White House national security adviser Jake Sullivan stressed that the framework would ensure that the most cutting-edge aspects of AI would be developed within the United States and with its closest allies, instead of possibly getting offshored such as the battery and renewable energy sectors.

A tech industry group, the Information Technology Industry Council, warned Raimondo in a letter last week that a hastily implemented new rule from the Democratic administration could fragment global supply chains and put US companies at a disadvantage.

The framework includes 120-day comment period, the incoming Republican administration of President-elect Donald Trump could ultimately determine the rules for the sales abroad of advanced computer chips.


## Incoming prez-elect team screens loyalties of civil servants at WH

### WASHINGTON

INCOMING senior Trump administration officials have begun questioning career civil servants who work on the White House National Security Council about who they voted for in the 2024 election, their political contributions and whether they have made social media posts that could be considered incriminating by President-elect Donald Trump's team, according to an official familiar with the matter.

At least some of these non-political employees have begun packing up their belongings since being asked about their loyalty to Trump after they had earlier been given indications that they would be asked to stay on at the NSC in the new administration, the official said, speaking on the condition of anonymity to discuss sensitive personnel matters.

Trump's pick for national security adviser, Florida Rep Mike Waltz, in recent days publicly signalled his intention to get rid of all nonpolitical appointees and career intelligence officials serving on

the NSC by Inauguration Day to ensure the council is staffed with those who support Trump's agenda.

A wholesale removal of foreign policy and national security experts from the NSC on Day 1 of the new administration could deprive Trump's team of considerable expertise and institutional knowledge at a time when the US is grappling with difficult policy challenges in Ukraine, the Mideast and beyond.

Such questioning could

also make new policy experts brought in to the NSC less likely to speak up about policy differences and concerns.

The NSC staff members being questioned about their loyalty are largely subject matter experts who have been loaned to the White House by federal agencies the State Department, FBI and CIA, for example for temporary duty that typically lasts one to two years. If removed from the NSC, they would be returned to their home agencies. AP

# Russia says Ukraine attacked pipeline carrying gas to EU

## MOSCOW

RUSSIA accused Ukraine on Monday of launching a drone attack on the infrastructure of a major gas pipeline that carries Russian supplies to Europe via Turkey.

The allegation – which Kyiv has not commented on – comes amid an escalating energy row between the two countries, almost three years after Russia launched its full-scale military offensive.

Kyiv halted the transit of Russian gas via Ukraine on January 1 – ending decades of energy cooperation that had brought billions of dollars to both countries – in a bid to cut off revenue for Moscow's army. Slovakia is facing the brunt of high gas price after Ukraine cut off supplies.

The Russian defence ministry said Ukraine had fired nine attack drones on Saturday at a gas compressor station in the village of Gai-Kodzor, near Russia's southern coast on the Black Sea.

The site is across from the annexed Crimean peninsula – heavily targeted by Kyiv throughout the three-year conflict. It said the facility was part of the TurkStream pipeline and accused Ukraine of trying to "cut off gas supplies to European countries". Slovakia facing the brunt of high gas price after Ukraine cut off supplies.

"All the drones were shot down," the defence ministry said in a statement.

"As a result of falling fragments of one drone, a building and equipment of a gas measuring station suffered minor damage," it added, saying there was no disruption to supply and the facility was working as normal.

TurkStream runs for 930 kms under the Black Sea from the Russian resort city of Anapa to Kiyikoy in northwestern Turkey, before connecting to overground pipelines that run up through the Balkans to Europe. After the claimed attack, EU member Hungary, which receives Russian gas via the route, called on its "security and operability" to be "respected by all".

"The security of energy supply is a sovereignty issue, so any action that threatens the security of our energy supply must be seen as an attack on sovereignty," Foreign Minister Peter Szijjarto said.

The 27-member EU has been reducing its dependence on Russian gas since Moscow launched its full-scale military offensive on Ukraine in February 2022. Despite imports via pipeline having fallen, several European countries have increased their purchases of Russian LNG. AFP

## 'Sanctions on Russian oil to destabilise global market'

### MOSCOW

THE Kremlin said on Monday that the latest US sanctions on Russia's oil sector would "destabilise" the global energy market, after Washington imposed punitive measures on Russian company Gazprom Neft. "Such decisions cannot but lead to a certain destabilisation of the global energy market," Kremlin spokesman Dmitry Peskov told reporters.

President Joe Biden's administration announced that it's expanding sanctions against Russia's critically important energy sector, unveiling a new effort to

inflict pain on Moscow for its grinding war in Ukraine as President-elect Donald Trump gets set to return to office vowing to quickly end the conflict. The outgoing Democratic administration billed the new sanctions as the most significant to date against Moscow's oil and liquefied natural gas sectors, the driver of Russia's economy. Officials said the sanctions, which punish entities that do business with the Russians, have the potential to cost the Russian economy upward of billions of dollars per month.

More than 180 oil-carrying vessels that are suspected to be part of a shadow fleet utilized by the

Kremlin to evade oil sanctions as well as traders, oil field service firms and Russian energy officials are also targeted by the new sanctions. Several of the vessels targeted are also suspected of shipping sanctioned Iranian oil, according to the Treasury Department.

"Putin is in tough shape right now, and I think it's really important that he not have any breathing room to continue to do the god-awful things he continued to do," Biden told reporters.

In the move coordinated with Washington, the UK also slapped sanctions on Russian energy firms. AP/AFP

Graft charge against Hasina could put UK minister in soup

## DHAKA

BANGLADESH's anti-graft commission has filed cases against ousted leader Sheikh Hasina and her family, including a British government minister and a senior United Nations official, its chief said Monday.

The cases are linked to an alleged large-scale land grab of lucrative plots in a suburb of the densely populated capital Dhaka.

"Sheikh Hasina, in collaboration with some officials, allocated plots for herself and her family members," Anti-Corruption Commission (ACC) director general Akther Hossain told reporters.

Hossain said those named in the case include Hasina's niece, British anti-corruption minister Tulip Siddiq. But Siddiq insisted she has done nothing wrong.
