

Protests erupt over 'Jai Maharashtra' slogans

MEMBERS of the Kittur Karnataka Sene (KKS) staged a protest in front of the Deputy Commissioner's office, demanding legal action against Maharashtra Minister Shiven-drasinh Raje Bhosale, MLA Abhay Patil, Mayor Savita Kamble and their supporters, in Belagavi on Tuesday. They protested against the alleged provocative incident during the inauguration of the unveiling of Dharmaveer Sambhaji's statue at Angol in Belagavi on Sunday.

tended the event, where he shouted the slogan "Jai Maharashtra", which was reportedly applauded by MLA Patil and Mayor Savita.

In a memorandum submitted by the KKS, members highlighted that the Karnataka government spent Rs 45 lakh on the statue from the taxpayers' money. They described the acts of Maharashtra representatives and local leaders as an insult to the people of Karnataka. The Swabhimani Kannadigara Okkuta also joined the call for strict legal action against those involved.

The agitators accused minister Bhosale, MLA Patil and Mayor Savita of defying the district administration's orders and using the event to provoke sentiments by shouting "Jai Maharashtra."

It may be recalled here that the district administration had earlier ordered the postponement of the unveiling ceremony due to incomplete work. However, minister Bhosale at-

Biker killed in road mishap

A 33-year-old man was killed and another critically injured when their bike lost control on the Khanapur-Belagavi highway near Hattargunji, resulting in a severe crash, in Khanapur recently. The accident occurred on Sunday evening.

The deceased, Vikram Maruti Patil from Bahadurwadi and pillion rider Atul Chandrakant Patil, were returning home after visiting their relatives in Karambal and were going via Bahadurwadi.

Atul was seriously injured in the accident and is undergoing treatment at a hospital. Vikram, who was riding the bike, sustained critical head and chest injuries. He was immediately rushed to a private hospital in Belagavi, where he succumbed to his injuries on Monday. A case has been registered at Khanapur police station.
