

# New Year revelry in Kochi concludes with vibrant Cochin Carnival rally

The New Year revelry in Ernakulam district concluded late on Thursday evening with the much-awaited Cochin Carnival rally being taken out from Veli Ground to Parade Ground which is located right in the heart of the Fort Kochi heritage zone.

Although slated to be held on December 31 each year, the crowd-pulling event was postponed to January 2 due to the week-long mourning following the death of former Prime Minister Manmohan Singh. As is the norm each year, floats depicting an array of themes, people wearing fancy dress, dancers and others participated in the rally held on the day. A robotic elephant was among the attractions.

Foreign tourists, other visitors and people from the city and West Kochi turned up in large numbers to witness the rally which was followed by live music performance at Parade Ground.

People converged at Fort Kochi by road and in passenger/ro-ro ferries. This is the first time that the Cochin Carnival is being held after the extension of Water Metro ferries to Fort Kochi.



## Capital to host school arts fest from tomorrow

The State capital is gearing up to host the State School Arts Festival after a gap of nine years.

Nearly 15,000 students will take part in the festival across 25 venues. The Arabic Sahityotsavam and the Samskritotsavam will also be held along with the arts festival.

The welcome song for the festival has been penned by Srinivasan Thooneri and set to tune by Kavalam Sreekumar. Its dance interpretation will be presented jointly by the students of Kerala Kalamandalam and State schools. Students of GVHSS, Vellarmala, Wayanad, will present a group dance on the theme of survival, Minister for General Education V. Sivankutty said at a press conference here on Thursday.

Director of General Education Shanavas S. will hoist the flag at Central Stadium, the main venue that has been named MT-Nila in memory of the late writer M.T. Vasudevan Nair at 9 a.m. on Saturday. Chief Minister Pinarayi Vijayan will formally inaugurate the festival at 10 a.m.

Nineteen subcommittees have been formed for the smooth conduct of the festival.

Registration of participants will begin at SMV Higher Secondary School at 10 a.m. on Friday. Seven counters have been arranged for the 14 districts.

Arrangements have been made on the web portal www.ulsavam.kite.kerala.gov.in for students to record at the time of online registration if they need accommodation. Twenty-five schools have been identified for housing the students, with 10 schools in reserve.

The food pavilion has been put up at the Putharikandam grounds. Pazhayidom Mohanan Namboothiri will manage the massive festival kitchen this year too. At a time, 4,000 students will be able to eat at the pavilion. It will open with dinner for the participants on Friday. Arrangements have been made for students to take away hot water.

The festival will observe the green protocol. Experts from within the State and outside have been selected as judges by the Directorate of General Education in a transparent manner.

The festival valedictory will be held at 5 p.m. on January 8.
