Superintendent of Police (SP) G. Bindhu Madhav said the accused, B. Rajesh, misbehaved with a 10-year-old girl. Rajesh used to show indecent pictures to the girl and harass her. Based on a complaint by the girl's mother, the Kurnool III Town police registered a case under POCSSO Act in June 2021.

Kurnool Special POCSSO Court Judge Bhupal Reddy sentenced Rajesh to three year imprisonment and imposed ₹20,000 fine.
