

150 constable drivers complete training

State Police Chief (SPC) Shaik Darvesh Saheb received the salute during a joint passing-out parade of 150 police constable drivers, who completed their training at the India Reserve Battalion (IRB).

Addressing the new recruits, the SPC emphasised the need for them to adapt to modern technologies and be proficient in new skills to meet the challenges of changing times.

The ceremony, held at the IRB Parade Ground in Thrissur on Wednesday, saw 21 recruits from the Malappuram MSP Battalion, 43 from the SAP Battalion, and 14, 12, 32, 15, and 13 recruits from the KAP 1, 2, 3, 4, and 5 battalions, respectively, all of whom had completed six months

of basic training to join the Kerala Police.

The oath taken by the recruits to mark their entry into the police force has been modified to avoid gender distinctions. Vishnu Mahendra was the parade commander and S. Nabeel Shah served as the second-in-command.

Training areas

The training focussed on enhancing police's professional expertise as envisioned by the government such as better interactions with the public and upholding the police motto of 'Soft in manner, firm in duty'.

Training was given in physical fitness, weapon handling, swimming, firing practice, unarmed combat, yoga, traffic drills, and more. Indoor training covered topics such as basic automobile engineering,

stress management, behaviour with senior officers, and various traffic laws.

The recruits were also given training in driving different department vehicles, including specialised ones such as cranes, recovery vehicles, baggage scanners, and VIP motorcades. Practical training was provided on modern vehicles used by the department.

The State Police Chief honoured those who showed exemplary performance during the training.

The ceremony was attended by senior police officers, including Armed Police Battalion Additional Director General of Police M.R. Ajith Kumar, Deputy Inspector General of Police R. Anand, and IRB Commandant M. Hemalatha, along with other dignitaries and local officials.

The panel headed E. Balaguruswamy, former member of the Union Public Service Commission and Vice-Chancellor, Anna University, has submitted its report to Agriculture Minister P. Prasad, the Agriculture department said in a statement on Wednesday. According to the department, the report contains recommendations pertaining to improving the university's revenue generation and opening affiliated colleges. The government had appointed the panel in May 2023 to prepare recommendations for revamping KAU.

Unauthorised board near Secretariat: HC orders police probe

The Kerala High Court on Wednesday directed the State Police Chief to constitute a competent team of officers to ensure that an investigation into a complaint of the Thiruvananthapuram Corporation was conducted swiftly to verify those responsible for a huge board installed allegedly under the aegis of the Kerala Secretariat Employees Association in front of the Secretariat.

Justice Devan Ramachandran ordered that the investigation should reveal

the identities of those responsible as well as that of the printer/advertisement agency responsible for putting it up.

The court was told by the amicus curiae that the board had been removed immediately after the illegal installation was widely reported in the media.

The court observed that there were larger issues involved in this matter. If the illegal board was installed by an association of employees of the government, then certainly it was in breach of government orders and judicial directives.
