

# Tigers set up title clash with Toofans

The former edges out Tamil Nadu Dragons in shootout in the first semifinal while the latter outclasses Soorma Hockey Club

In a nerve-wracking penalty shootout, Shraichi Karh Bengal Tigers was 0.2 seconds from missing out on the Hockey India League (HIL) final when Florent van Aubel's sudden death barely beat the buzzer.

Then, goalkeeper Tim Cross thwarted Uttam Singh while Abhishek made no mistake with his penalty to take his team through with a 6-5 shootout victory over Tamil Nadu Dragons in the first semifinal at the Birsu Munda Hockey Stadium here on Friday.

In a stop-start game filled with multiple video referrals, Tigers dug deep and clawed back twice to force a 2-2 draw in regulation time, despite struggling in their strongest - suit - failing to convert from eight penalty corners. From a lightning counter-attack, Abhishek brilliantly set up Pardeep Singh Sandhu to score into an empty net and equalise right at the end of the first half to cancel out Nathan Ephraums' opener.

Dragons needed less than two minutes from the restart to go ahead once again through Selvam Karthi and had the advantage with Tigers being a man down for 10 minutes. Colin Batch's men fell back to

close down the space while Dragons looked out of ideas to make the most of the numerical advantage.

In the fourth quarter, Tigers made it pay when they pulled level again courtesy Sam Lane who flicked it past David Harte to take his side into the shootout.

Tigers will take on Hyderabad Toofans in the title-decider on Saturday after it thrashed Soorma Hockey Club 3-1 in the second semifinal.

There were no heroics from skipper Harmanpreet Singh and goalkeeper Vincent Vanasch to bail out Soorma as Toofans held their shape well and tore apart the opponent with their incisiveness and speed.

After a sedate start, Toofans took the lead through Amandeep Lakra who angled a bullet drag-flick into

the middle of the right corner to put Toofans 1-0 up.

Soorma looked uninspiring in attack and from short corners, squandering 14 attempts against Toofans' resolute penalty corner defence before Jeremy Hayward found the mark right at the death.

In the second half, Harmanpreet Singh's long ball was cut out before Toofans blitzed through the middle, ending with Jacob Anderson sliding the ball home to double the lead. For the third, Nilakanta Sharma sounded the boards from another counter.

**The results:** Bengal Tigers 2 (Pardeep Singh Sandhu 30, Sam Lane 53) drew with Tamil Nadu Dragons 2 (Nathan Ephraums 18, Selvam Karthi 32); Tigers won the shootout 6-5; Soorma 1 (Jeremy Hayward 60) lost to Hyderabad Toofans 3 (Amandeep Lakra 25, Jacob Anderson 35, Nilakanta Sharma 43).

He is just 17 and the National Games shooting's men's 10m air rifle final field had some big names, including World No. 4 Arjun Babuta who narrowly missed a bronze at the last Olympics, another Paris Olympian Sandeep Singh and 2022 World champion Rudranksh Patil.

But Maharashtra's Parth Mane did not feel a shiver, in fact he appeared to thrive under pressure.

Despite being a junior, Parth has seen and beaten bigger names.

He had shocked Sweden's World champion Victor Lindgren, the Paris Olympics silver medallist, while winning the Junior World Championship gold in Lima, Peru, last October.

"Pressure helps me, it helps me focus on the tar-

get. The Junior World gold definitely gave me confidence, it helped me here also," said Parth after winning the gold here on Friday.

Parth, who is coached by Olympian Suma Shirur at her Lakshya Shooting

Academy in Panvel, was a steady shooter in the air rifle final.

He led the pack after the first set of five shots and then after 10 and 12 in the 24-shot final. Services' Kiran Jadhav briefly took the lead after 14 shots but Parth was quick to regain it after the next two shots. Rudranksh and Arjun, occupied the next spots behind Parth after 18 shots while Sandeep made his exit at that point.

Arjun left after 20 shots to finish fourth while Parth grew in strength to grab the gold (252.6 points) with his Maharashtra teammate Rudranksh (252.1) and Kiran (230.7) taking silver and bronze.

# Bindyarani breaks Mirabai's record

S. Bindyarani Devi broke former Olympic silver medallist Mirabai Chanu's snatch National record while winning the National Games women's 55kg weightlifting gold at the Maharaja Pratap Sports Complex here on Friday.

After fumbling with her opening effort (83kg), the 26-year-old from Manipur successfully lifted 88kg to better Mirabai's record which came in 2022 in a Singapore meet.

"I already hold the clean and jerk National record, my goal was to get the snatch record here," said Bindyarani who lifted 113kg in clean and jerk for a gold-winning total of 201kg. "I've been lifting 91kg in snatch in training," Haryana men and Od-
