US CLARIFIES TARIFFS ON CHINA IS 145%; EU PAUSES RETALIATION FOR 90 DAYS

White House says the 125% is over and above the 20% already imposed by Trump earlier

WASHINGTON

THE US-China trade war intensified Thursday, sending the global economy into unknown territory and dampening relief after President Donald Trump's earlier climbdown from a wider tariff onslaught against the rest of the world.

The White House clarified that Trump's big hike in tariffs on China announced 24 hours earlier had actually taken his total levies this year on imports from the world's second biggest economy to a staggering total of 145 per cent — not the previously reported 125 per cent.

This was because latest tariff hike comes on top of a 20 percent tariff already imposed earlier. The superpower confrontation threw a deep shadow over jubilation that Trump was retreating from threats to impose punishing tariffs on dozens of other countries — everywhere from European Union allies to Asian manufacturing hubs like Vietnam and even tiny, remote ocean islands.

Trump maintained a blanket

10 percent tariff on most countries. However, his retreat from more damaging levies against European countries prompted the EU to pause plans for its own retaliation. Amid relief, Asian and European stock markets rocketed, with Tokyo closing 9.1 percent higher.

But realisation that Trump's splashy about-face on Wednesday masked the reality of a surging trade war with China dampened spirits.

The Dow Jones in New York fell more than three percent and the S&P dropped 4.5 percent in morning trading. Gold prices hit a record high as the US dollar crumbled. Amid questions over how far Trump is ready to push, the European Union welcomed the US president's partial row-back on his original threat to impose 20 percent tariffs against the bloc.

The 27-nation grouping responded with its own olive branch, suspending for 90 days tariffs on 20 billion euros' worth of US goods that had been greenlit in retaliation to duties on steel and aluminum.

Trade war: China's 84% tariffs on US imports take effect

Tariffs of 84 per cent on all Chinese imports of American goods took effect on Thursday, deepening a trade war between Beijing and Washington which has rocked global markets and sparked fears of a recession. Levies will apply to all US products entering the world's second-largest economy, which according to the office of the US Trade Representative, totalled \$143.5 billion in 2024. In Hong Kong, local office of China's Foreign Ministry's spokesperson reiterated Beijing's unwillingness to negotiate with the US under current conditions.

China seeks allies as Don raises tariffs, vows to fight till the end

CHINA is reaching out to other nations as the US layers on more tariffs in what appears to be an attempt to form a united front to compel Washington to retreat. Days into the effort, it's meeting only partial success with many countries unwilling to ally with the main target of President Donald Trump's trade war.

Facing the cratering of global markets, Trump on Wednesday backed off his tariffs on most nations for 90 days, saying countries were lining up to negotiate more favorable conditions. China has refused to seek talks, saying it would "fight to the end" in a tariff war, prompting Trump to further jack up the tax rate on Chinese imports to 145 per cent. China has retaliated with tariffs on US goods of 84 per cent, which took effect Thursday.

Trump's move was seemingly an attempt to narrow what had been an unprecedented trade war between the US and most of the world to a showdown between the US and China.

"A just cause receives support from many," Foreign Ministry spokesperson Lin Jian said at a daily briefing on Thursday. "The US cannot win the support of the people and will end in failure." China has thus far focused on Europe, with a phone call between Premier Li Qiang and European Commission President Ursula von der Leyen "sending a positive message to the outside world."

"China is willing to work with the EU to jointly implement the important consensus reached by the leaders of China and the EU..." the official Xinhua News Agency reported.

Russia, US swap high-profile prisoners amid tensions

DUBAI: Moscow freed a Russian American convicted of treason in exchange for a Russian German man jailed on smuggling charges in the US, a prisoner swap that was completed Thursday as the two countries met to repair ties. Ksenia Karelna is "on a plane back home to the United States," US Secretary of State Marco Rubio said in a post on social media platform X. She was arrested in the Ural Mountains city of Yekaterinburg in February 2024 and convicted of treason on charges stemming from a donation of about \$52 to a charity aiding Ukraine. US authorities have called the case "absolutely ludicrous." Arthur Petrov was released as part of a swap in Abu Dhabi, United Arab Emirates, according to the Federal Security Service, or FSB, Russia's main security and counterintelligence agency.
