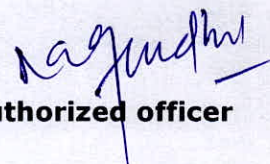
### **Terms and Conditions of E-Auction**

2. 3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.
